RECOMMENDATIONS

 Accept the work performed for the Lemon Grove Recreation Center – Sports Field and Court Lighting (AKA Proposition (Prop) K Sports Lighting Improvement: Lemon Grove RC) (PRJ21136) (W.O. #E170506) Project (Project), constructed by the Department of Recreation and Parks (RAP) as-needed prequalified on-call vendors, as outlined in the Summary of this Report.

SUMMARY

The Project is located at 4959 Lemon Grove Avenue, Los Angeles, CA 90029 in Council District 13. This 3.87-acre facility provides a recreation center, baseball field, outdoor fitness equipment, basketball courts, and a jogging path. Approximately 13,319 City residents live within a half mile walking distance of the recreation center.

This Project is a Proposition – L.A. for Kids Program (Proposition K) funded project. The scope of work consisted of replacing existing lighting at one baseball field and two basketball courts with new Light Emitting Diode (LED) lighting fixtures.

On July 17, 2019, the Board of Recreation and Park Commissioners (Board) approved the final plans for the Project (Report No. 19-144), and bids for the work were solicited from RAP's pre-qualified contractors. Electro Construction Corporation was determined to be the lowest responsive and responsible bid, and a Notice to Proceed letter was issued on October 28, 2019.

Plans for the Project were prepared by the RAP Planning, Maintenance and Construction Branch. The Bureau of Engineering (BOE) provided construction management services.

BOE has reviewed the as-built plans and has informed RAP that the Project is complete in accordance with the plans and specifications. RAP confirmed that there are no unresolved contract compliance or labor issues related to the work completed.

During the course of construction, only one Change Order was issued for the Project, in the amount of \$9,888.00 or 5.6% of the base award amount. This single change order was attributed to the additional scope requested by RAP for adding electronic communication hardware to track and monitor the energy usage of the new LED lights.

TREES AND SHADE

No trees were removed as part of this Project. Existing trees near the location of the improvements were protected during the construction period.

ENVIRONMENTAL IMPACT

The Board reviewed and evaluated the environmental impact of the Project in accordance with the California Environmental Quality Act (CEQA), and determined that it is categorically exempt from the provisions of CEQA (Report No. 20-062). No additional CEQA documentation is required for the acceptance of the Project.

FISCAL IMPACT STATEMENT

There is no immediate fiscal impact to RAP's General Fund. The Project should reduce long-term maintenance and operational costs, as it replaced existing, higher energy use sports court lighting systems with energy efficient LED lights.

STRATEGIC PLAN INITIATIVES AND GOALS

Approval of this Board Report advances RAP's Strategic Plan by supporting:

- 1. Approve the final plans and specifications, substantially in the form attached to this Report, for the Lemon Grove Recreation Center Sports Field and Court Lighting (AKA Proposition (Prop) K Sports Lighting Improvement: Lemon Grove RC) (W.O. #E170506) Project (Project);
- 2. Find the that proposed Project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA), pursuant to Article III, Section 1, Class 1(1), Class 1(4), and Class 1(12) of City CEQA Guidelines and Article 19, Section 15301(d) of California CEQA Guidelines, and direct Staff to file a Notice of Exemption (NOE) with the City and the Los Angeles County Clerk's Office; and,

<u>SUMMARY</u>

Lemon Grove Recreation Center is located at 4959 Lemon Grove Avenue, in Council District 13. This 3.87 acre recreation center provides a recreation center, baseball field, outdoor fitness equipment, basketball courts, and a jogging path. Approximately 13,319 City residents live within a half-mile (1/2) walking distance of the recreation center.

The Project is a Proposition K – L.A. for Kids Program Competitive Grant funded project.

The Project scope of work consists of replacing existing lighting at one (1) baseball field and two (2) basketball courts with new Light Emitting Diode (LED) light fixtures. This will provide an improved quality of lighting with reduced spillover of light onto adjacent properties and/or other areas of the recreation center. The new LED light fixtures will also reduce operational costs, by reducing energy consumption relative to current electrical usage.

After review by staff of RAP and Department of Public Works, Bureau of Engineering (BOE) staff, it was determined that the work can be performed by RAP pre-qualified on call contractors. RAP staff recommends the Project be constructed by the on call contractors and recommends BOE provide construction management services during the construction of these improvements.

RAP's Planning, Construction, and Maintenance Branch prepared the plans and specifications for the Project, and obtained all the necessary permits for the Project. The final plans for the Project are attached to this Report and are submitted to the Board of Recreation and Park Commissioners (Board) for approval through this Report. As required by the Proposition K, three (3) Local Volunteer Neighborhood Oversight Committee (LVNOC) meetings were conducted. The first LVNOC meeting was held on December 15, 2016. The second LVNOC meeting was held on April 28, 2017. The third LVNOC meeting was held on May 15, 2017. The community, LVNOC and Office of Council District 13 are in full support of this Project.

TREES AND SHADE

The Project does not require any trees removal. Existing trees near the location of proposed new lighting fixtures will be protected during the construction period. Since this Project focuses on improving lighting for evening recreation activities, additional trees and shade structures are not part of the scope of work. Furthermore, the approved Prop K funds for this Project do not include funding for installation of shade structures and/or trees.

ENVIRONMENTAL IMPACT

The proposed Project consists of minor construction work to replace existing lighting with new LED lighting fixtures for security reasons. As such, RAP staff recommends that the Board

determines that the proposed Project is Categorically Exempt from the provision of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 1(1), Class 1(4), and Class 1(12) of City CEQA Guidelines and Article 19, Section 15301(d), of California CEQA Guidelines.

FISCAL IMPACT

There is no immediate fiscal impact to RAP's General Fund. When completed, the Project should reduce long term maintenance and operational costs, due to replacement of existing and high energy consumption of sports court lighting systems with new and energy efficient LED lighting systems.
