SALARY: \$17.81 /hour

DUTIES: Checks in and out patrons' clothing; cleans dressing rooms, showers, restrooms and other parts of the pool building including trash cans on the pool deck; enforces proper patron conduct by communicating pool health and safety regulations; and may be assigned related work.

As a condition of employment, a Locker Room Attendant must attend all in-service trainings and must work a minimum of 20 hours (does not include paid training/orientation, holidays or any compensated time off) between Memorial Day and Labor Day in order to continue employment with Citywide Aquatics (beyond Labor Day).
