SEASONAL POOL MANAGER I

(Code No. 2409)

This position is exempt from civil service.*

THIS EXAMINATION IS GIVEN TO FILL USA SWIMMING COACHING POSITIONS ONLY

SALARY: \$24.18/hour (The current salary is subject to change. You may confirm the starting salary with the hiring department before accepting a job offer).

DUTIES: Lead aquatic facility staff; act as a lifeguard; assist in the operation of a municipal pool and is in charge in the supervisor's absence; conduct swimming and lifesaving classes; organize and coach water sports; organize and lead aquatic camp, develop, direct and promote the activities of a municipal swimming pool; and instruct in swimming and lifesaving techniques.

Work assignment will be with the PLAYLA Swim Team program. Those that wish to work outside of the PLAYLA Swim Team program may work limited hours outside of the PLAYLA Swim Team program with approval from Aquatics Upper Management if all required certifications, manager workshops and in-service training is completed.

It is expected that PLAYLA Swim Team Pool Managers will work a minimum of ten (10) hours per week and if qualified may work up to ten (10) additional hours outside of the PLAYLA Swim Team hours with approval from Aquatics Upper Management.

REQUIREMENT(S)/MINIMUM QUALIFICATIONS:

1. EXPERIENCE:

- Two (2) full summer seasons paid experience as a Los Angeles City Lifeguard; and
- Attend all mandatory manager training prior to Opening Day.
- Must have knowledge of competitive rules, including techniques, and event/tournament operations; **and**
- 4 seasons or more coaching at the level of USA, Collegiate, High School, or Novice Swimming; **or**
- 2 years or more participating in USA, Collegiate, High School, or International Swimming

2. **AGE:** 18 years of age by position start date. Proof of age with picture ID will be required at the interview.

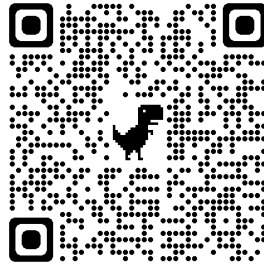
