SUMMARY:

Submitted are final plans and specifications for the Field of Dreams - Field House project, located at 501 Westmont Drive, Los Angeles, California, 90731. The construction of this project will be funded by Prop 12 2/3 Per Capita, and Sites and Facilities funds. The plans provide for the construction of a new restroom facility. The proposed structure is a one-story, 1,200 square foot field house restroom facility that consists of eight unisex, and two handicap, toilet stalls, with four lavatories. The installation of a walkway, several ADA parking spaces, minor irrigation and landscaping are also part of the project. The facility will be used by park patrons, as well as participants in the facilities' sports activities and gatherings.

This is Department of Public Works, Bureau of Sanitation land, which will be transferred to RAP when they complete landfill closure construction.
