On August 14, 2007 the Board accepted the work on the project as complete and A.W.I. Builders, Inc. was furnished with a letter of completion. Flintridge Landscape Company, Inc., Baron Brothers Nursery, Inc. and Konila Electrical Services, Inc. were required to perfect their respective stop notice claims within 180 days of the Board's acceptance of the project and were notified in writing on February 26, 2008 to respond within 15 days whether their stop notices had been perfected. Flintridge Landscape Company, Inc., Baron Brothers Nursery, Inc., and Konila Electrical Services, Inc., failed to respond; the 180-day period has expired and Civil Code Section 3210 requires that the funds withheld be paid to the contractor. Therefore, it is now in order to release the subject funds to A.W.I. Builders, Inc.
