funding sources and amounts, substantially in the form on file in the Board Office, between the Department of Recreation and Parks (RAP), the Bureau of Engineering (BOE) and the Department of General Services (GSD) subject to the approval of the City Attorney as to form;

- 3. Direct the Board Secretary to transmit the Supplemental MOU to the City Attorney for approval as to form; and
- 4. Authorize the General Manager to execute the Supplemental MOU; subject to the approval of the City Attorney as to form.

SUMMARY:

On June 4, 2003, the Board approved the transfer of \$325,000 from Proposition K and \$135,000 from State Proposition 12 Local Operated Units (LOU) Grant, for a total of \$460,000 to GSD for repair work at the Drum Barracks Civil War Museum (Board Report No. 03-187); however, when the MOU agreement between RAP, BOE, and GSD was submitted to the Board, the Proposition 12 LOU Grant was inadvertently omitted. The Board approved the MOU for \$460,000 from Proposition K only. Subsequently, City Council approved \$460,000 from Proposition K (Council File #03-1827).

The project was completed on April 23, 2004, and accepted by the Board on February 21, 2007 (Board Report No. 07-38); however, the funding source and amounts need to be revised prior to project closeout. It is, therefore, requested that the Board approve the change in funding source to include the Proposition 12 LOU Grant funds as well as utilize the full grant amount of \$174,500 and to decrease the Proposition K amount from \$460,000 to \$285,500.

The remaining \$174,500 in Proposition K funds will be used for additional Proposition K eligible facility improvements at the Drum Barracks Civil War Museum.

FISCAL IMPACT STATEMENT:

There is no fiscal impact to the Department's General Fund since the source of the funds is from the State's Proposition 12 LOU Grant and Proposition K. The project cost remains at \$460,000.
