

SUBJECT: AUTHORIZATION TO ACCEPT TIRE-DERIVED PRODUCT GRANT PROGRAM FUNDS



<u>RECOMMENDATION</u>:

That the Board:

- 1. Concur with the City Council's action to accept the California Integrated Waste Management Board Tire-Derived Product Grant awarded to the Department of Recreation and Parks in the amount of \$59,204 to replace damaged and worn park playground surface tiles throughout the City with 100% recycled tire-derived materials; and
- 2. Authorize the General Manager or designee of the Department of Recreation and Parks to negotiate and execute forthwith any resulting agreements with the California Integrated Waste Management Board subject to approval as to form by the City Attorney, and to submit all documents necessary to request and receive the grant program funds from the California Integrated Waste Management Board.

SUMMARY:

The California Integrated Waste Management Board (CIWMB), a unit of the State of California Environmental Protection Agency, works in partnership with local governments, industry and the public to promote effective waste recycling and management. The Tire-Derived Product Grant is part of an effort by the CIWMB to safely manage the more than 40.2 million reusable and waste tires generated each year by funding projects that use tire-derived materials.

The Department submitted the grant application to the CIWMB on November 16, 2007 to replace damaged and worn park playground surface tiles at 18 park playgrounds throughout the City with 100% recycled tire-derived materials from the CIWMB. On March 21, 2008, the Department was awarded \$59,204 to fund these projects at the following parks:
