SUMMARY:

On May 20, 2009, the Commission approved the allocation of \$5,220,000 in Subdivision/Quimby Fees from the Spring Street Park Account No. 460K-SZ for the Spring Street Park Acquisition project (#20120) in Board Report No. 09-068. Staff seeks approval to change the account sources and amounts being allocated to the project.

Upon the approval of this report, staff will change the account sources and amounts of funds being transferred into the Spring Street Park Account No. 460K-SZ for the Spring Street Park Acquisition project (#20120) as follows:

- \$1,060,895.80 in Subdivision/Quimby Fees, which were collected in Fiscal Year 2004-2005, from the Subdivision/Quimby Fees Account No. 460K-00
- \$546,526.50 in Zone Change/Park Fees, which were collected in Fiscal Year 2005-2006, from the Zone Change/Park Fees Account No. 440K-00
- \$607,281.26 in Subdivision/Quimby Fees, which were collected in Fiscal Year 2005-2006, and were previously allocated to the 3rd and Rose Street Park Acquisition project (#1114A), approved on June 20, 2007 per Board Report 07-140, from the 3rd and Rose Street Park Account No. 460K-TH

- \$35,035.54 in Subdivision/Quimby Fees, which were collected in Fiscal Year 2005-2006 and were previously allocated to the 3rd and Rose Street Park Account No. 460K-TH per Board Report No. 07140 on June 20, 2007, from the 3rd and Rose Street park Account No. 460K-TH
- \$1,522,711.90 in Subdivision/Quimby Fees, which were collected in Fiscal Year 2005-2006, from the Subdivision/Quimby Fees Account No. 460K-00
- \$1,447,549 in Subdivision/Quimby Fees, which were collected in Fiscal Year 2006-2007, from the Subdivision/Quimby Fees Account No. 460K-00

The total Subdivision/Quimby Fees allocation for the Spring Street Park Acquisition project (#20120) is \$5,220,000. This allocation is the same total as previously allocated, but from different accounts, and is sufficient to complete the project. These fees were collected within one mile of Spring Street Park, which is the standard distance for the allocation of the Subdivision/Quimby Fees for neighborhood recreational facilities.

FISCAL IMPACT STATEMENT:

There is no impact to the Department's General Fund.
