- 1. Approve final acceptance of the work performed by L.A. Builders, Inc., under Contract No. 3213, the Orcutt Ranch Refurbishment of Buildings and Grounds Americans with Disabilities Act (ADA) Access Improvements (W.O. #E170211F) as outlined in the body of this report;
- 2. Authorize the Department's Chief Accounting Employee to release all retention monies held under Contract No. 3213 to L.A. Builders, Inc., 35 calendar days after acceptance by the Board; and,
- 3. Authorize the Board Secretary to furnish L.A. Builders, Inc., with a letter of completion.

### SUMMARY:

On April 19, 2007, the Board awarded Contract No. 3213 in the amount of \$1,696,155 to L.A. Builders, Inc., for the Orcutt Ranch - Refurbishment of Buildings and Grounds, ADA Access Improvements (W.O. #E170211F) project. The project site is located at 23600 Roscoe Boulevard, West Hills, CA 91304 (Report No. 07-90).

Plans for the project were prepared by the Architectural Division of the Bureau of Engineering. The design called for the installation of a new perimeter fence and wrought iron entry fence to replace existing; a new irrigation system to replace the existing in the orchard and community gardens;

grading and drainage improvements at the park entry, around buildings and in the stream area; installation of decomposed granite and gravel paths with markers for new trails; additional plantings at the orchard, stream area and various locations; installation of new walkways and security lighting adjacent to existing buildings; installation of new site furnishings, including a kiosk, benches, waste receptacles and signage; and the creation of an ADA accessible restroom and improvements to the existing parking area to provide an ADA accessible parking.

On July 11, 2007, the Board approved a request to allocate and transfer \$418,951 in Quimby/Park fees for the Orcutt Ranch - Refurbishment of Buildings and Grounds, ADA Access Improvements project (Board Report No. 07-163); and authorized the Bureau of Engineering's Project Manager to negotiate a change order, in an amount not-to-exceed \$418,951 to add bid Additive Alternate # 1 (the renovation of the existing historical barn) to the project.

The cost of this change order was based on the contractor's original additive alternate bid amount of \$376,000, which is 22.2% of the original contract award total. The remaining \$42,951 was to remain as a contingency for construction.

On November 7, 2008, the Board authorized the City Engineer (Board Report No. 08-292) to negotiate change orders, in an amount not-to-exceed \$154,927.25, up to a total not to exceed 35% of the original contract amount or \$593,654.

The project was completed with a total of 56 Change Orders issued in the amount of \$535,959 or 31.59% of the original contract. The final contract amount, including the Change Orders, is \$2,232,114.

The Bureau of Engineering (BOE), Construction Management, completed the construction management of the project under the Recreational and Cultural Facilities Program. The facility has remained accessible to the public during construction.

The BOE has consulted with the Office of Contract Compliance concerning the status of the labor compliance requirements and Affirmative Action requirements on the project. There are no known outstanding wage violations at this time and L. A. Builders, Inc., is in compliance.

### **FISCAL IMPACT STATEMENT:**

There is no immediate fiscal impact to the Department's General Fund. The costs for operations of the facility are already included in the Department's Fiscal Year 2009-2010 operating budget for facilities.

The Bond was filed in accordance with California Civil Code Section 3196, which states, if the original contractor or subcontractor disputes the correctness or validity or enforceability of any stop notice, the public entity may, in its discretion, permit the original contractor to file with the public entity a bond executed by a corporate surety, in an amount equal to 125 percent of the claim stated in the stop notice conditioned for the payment of any sum which the stop notice claimant may recover on the claim together with his costs of suit in the action, if he recovers therein. Upon the filing of such bond with the public entity, the public entity shall not withhold any money or bonds (where bonds are to be issued in payment for the work of improvement) from the original contractor on account of the stop notice.

### RECOMMENDATION:

That the Board:

- 1. Approve the proposed Amendment No. 2 to Permit and Operating Agreement No. 1516, substantially in the form on file in the Board Office, between the Department of Recreation and Parks (Department) and the Harbor Department (Harbor) for improvements to be performed within the Agreement area at Harbor's sole expense, subject to review and approval of the City Attorney;
- 2. Direct the Board Secretary to transmit the Amendment concurrently to the Mayor and to the City Attorney for review and approval as to form, in accordance with Executive Directive No. 3; and,

### SUMMARY:

On November 14, 1989, the Department executed an agreement (Permit and Operating Agreement No. 1516) with the Port of Los Angeles (also referred to as "Harbor" or "Harbor Department") for the maintenance and operation by the Department of certain waterfront property owned by the Harbor Department, known as Cabrillo Beach, including a boat launch ramp, adjacent parking lot, restroom building, landscaped area(s) and other related facilities.

On June 19, 2002, the Board approved the Amendment No. 1 to the Operating Agreement No. 1516 (Board Report No. 02-260) to delete a 39,157 square foot portion of the existing agreement premises to be incorporated into Permit No. 384, which is between the Department and Harbor, for the Department's operation of the Cabrillo Marine Aquarium premises and adjacent parking areas; and, approved a Second Amendment to Permit No. 384 adding the same 39,157 square foot portion of land to the Permit No. 384 existing permit premises to accommodate the Cabrillo Marine Aquarium expansion and improvement project which has been completed.


In a letter dated July 31, 2009 to the Department, the Harbor transmitted the proposed Second Amendment (Amendment) to Operating Agreement No. 1516. The proposed Amendment will allow the Harbor to make improvements to approximately 4.5 acres of space located on land permitted to the Department, including the addition of two public restroom buildings. During the term of this Agreement, Department shall cooperate with the Harbor Department to complete the improvements shown in the attached Exhibit A-3. All costs incurred for the construction of these improvements will be the responsibility of the Harbor Department.

The Amendment is supported by the Superintendent of the Pacific Region and the Councilmember of the 15<sup>th</sup> Council District.

### FISCAL IMPACT STATEMENT:

Improvements at the Cabrillo Beach Recreational Area under the San Pedro Waterfront Enhancement Project will be made by the Harbor Department, at no expense to the Department of Recreation and Parks.

### RECOMMENDATION:

That the Board:

- 1. Approve a proposed contract between the City of Los Angeles and John T. Malloy Incorporated (Contractor) for the removal, repair, and replacement of a sewer line in Griffith Park for a term of six (6) months, in an amount not to exceed \$80,000, substantially in the form on file in the Board Office, subject to the approval of the Mayor and the City Attorney as to form;
- 2. Find, in accordance with Charter Section 1022, that the Department of Recreation and Park (Department) does not have personnel available in its employ with sufficient time and expertise to undertake this specialized professional service and that it is more feasible to secure these services by contract;
- 3. Find, in accordance with Charter Section 371 (e)(10) and Los Angeles Administrative Code Section 10.15(a)(10), that the use of competitive bidding would be undesirable, impractical, or impossible due to the urgent nature of the required work and that a qualified contractor be available immediately to perform the work for public health and safety purposes;
- 4. Find, in accordance with Charter Section 372, that obtaining competitive bids or proposals for work to be performed pursuant to this agreement is not reasonably practicable or compatible with the City's interest due to the urgent nature of the work as a formal

competitive process would take up to twelve months to complete;

- 5. Direct the Board Office Secretary to transmit the proposed Contract, concurrently, to the Mayor in accordance with Executive Directive No. 3 and to the City Attorney for approval as to form; and,
- 6. Authorize the Board President and Secretary to execute the Contract upon receipt of the necessary approvals.

### **SUMMARY:**

Due to the immediate and urgent need to remove, repair, and replace a portion of the sewer line located at 5375 Red Oak Drive located in Griffith Park, the Department was forced to proceed with repairs prior to receiving Board approval. We are asking that the Board grant permission to enter into a contract retroactively in order to pay for the emergency work being performed. The damaged sewer line has on numerous occasions caused raw sewage to overflow thereby creating an immediate and on-going health hazard to the community and visitors to this area. In addition to the potential health hazard from exposure to raw sewage, the sewage breach has caused the immediate closure of the Park's main restrooms and the closures of restroom facilities at a concession stand and maintenance yard.

Sewer blockages have periodically occurred over the past two years in the aforementioned sewer line. The frequency of the blockages has grown over the last two years causing public facilities, including public restrooms to periodically be shut down and closed to the public. Department staff was no longer able to perform routine maintenance to prevent additional raw sewage exposure. The sewer line has deteriorated to the point that the line had to be replaced immediately.

The Department currently does not have a contract for sewer line removal, repair, and replacement work. Existing General Services Sewer Tie Contracts have recently expired and replacement contracts are currently out to bid. Staff requested informal quotes from the three prior City contractors (Williams Pipeline Contractors Inc., Charles King Company, Inc., and John T. Malloy Incorporated). John T. Malloy Incorporated (Contractor) is the only responding vendor that submitted a quote for this project.

The Contractor has performed sewer related work with the Department of Public Works Bureau of Engineering on the Secondary Sewer Renewal Program at Sunset Boulevard and Canyon Drive (Contract No. C-113295) and with the Department of General Services providing and installing sewer and storm drain tie-in connections (Contract No. C-109765).

Staff recommends the award of a contract to John T. Malloy Incorporated to remove, repair, and replace the sewer line at 5375 Red Oak Drive located in Griffith Park in an amount not to exceed \$80,000. The contract amount includes the Contractor's quote of \$59,876, and \$20,124 set aside to

pay for undetermined additional project costs due to unforeseen delays, unexpected changes to the scope of work and change orders.

### **SUMMARY**:

The Office of Council District Fifteen has consulted with Warren Resources of California, Inc. (Warren), and the Wilmington Neighborhood Council in order to identify surplus property owned by Warren that is suited for public recreational use. A subsidiary, Warren E&P, Inc., manages all their oil and natural gas exploration, production and related land management; the local headquarters is in Long Beach. Warren operates over 200 wells in the harbor area. A 2007 Zoning Order of the City of Los Angeles requires the firm to gradually abandon older Wilmington wells, many now in residential areas, in favor of slant and horizontal, centralized drilling that is less intrusive to the community. Two of the affected parcels are at 1037-41 Banning Boulevard, across from the Drum Barracks Civil War Museum. The parcels total 0.39 acre (Assessor Parcel Numbers 7423-018-015 and -029). The immediate neighborhood is residential although Warren has a centralized operations facility two blocks south of the Banning parcels.

Use of the parcels for petroleum production dates to the 1930s; all but one well was formally abandoned by 1994. Warren has owned the site since 2005 and in 2008 abandoned the remaining well under State supervision. Warren's proposed donation involves surface rights; subsurface rights will be retained as they are part of a larger leasehold belonging to the firm.

In addition to the Banning parcels, Warren recently proposed donating another nearby, small remediated lot at 1306 Ravenna Avenue. Instead, City staff proposed, and Warren informally agreed, that it would sell the lot and donate the proceeds to the Department of Recreation and Parks (Department) to partially fund the development and maintenance of the Banning parcels.

In July 2009, a Phase I site assessment was conducted for the Department. Because of previous remediation, including the replacement of contaminated soil, the report's single recommendation is that the two underground, abandoned pipelines be removed by a State-licensed contractor or plugged and left in place. There was no evidence of groundwater seepage or contamination and no recommendation for further soil remediation.

To facilitate recreational use of the Banning parcels, Warren installed irrigation along the northern and southern borders with a meter and tie-in to the City's water system. The middle of the property has three drains for surface runoff. Department landscape architectural staff visited the site and are ready to draft conceptual plans to present to the community and the Drum Barrack's support group. The director of that facility wants the plans to include a small parking lot. Other potential uses include a children's play area with a separate outdoor classroom for cultural and historical programs. Remaining open space can expand the temporary, civil war "encampments" or living-history displays that are now held at the Museum. These family-oriented, costumed events include "soldiers" and their armaments together with women and children demonstrating handicrafts and domestic chores. Since no structure is planned for the Banning parcels, their location within a Methane Zone, as defined by the Department of Building and Safety, does not pose an obstacle to the proposed public use.

Staff determined that the project will consist of the acquisition of land for park purposes with the development of accessory amenities and is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 11(2, 3), Class 25(5) of the City CEQA Guidelines.

In addition to the Office of Council District Fifteen, the Assistant General Manager of Operations East and the Superintendent of Pacific Region concur with staff's recommendations.

### FISCAL IMPACT\_STATEMENT:

Region operations staff estimates that the annual cost of maintaining the undeveloped site, including the installed irrigation and rental of a security chain-link fence, will be less than \$8,000. Landscape architecture staff estimate that developing the site with the amenities cited earlier will cost \$380,000. The financial benefit accruing from the sale of the Ravenna Avenue parcel is not yet known.

### **SUMMARY**:

The Department of Recreation and Parks Cabrillo Marine Aquarium is a non-profit public aquarium that engages all visitors in education, recreation, and research of the marine life of Southern California and has sponsored the annual whale-watching and ecological tour excursion, known as the "Meet the Friendly Whales of Baja" trip for the past 35 years. The Cabrillo Marine Aquarium Baja trip attracts passengers from across the country and furthers its international reputation as one of the finest teaching aquariums in the United States. The goal in sponsoring the trip is to further Cabrillo Marine Aquarium's mission of promoting knowledge, appreciation, and conservation of the marine life of Southern California. Staff recommends continuing the sponsorship of this year's trip which is scheduled for February 26, 2010 through March 6, 2010.

In accordance with Los Angeles Administrative Code Section 10.15 (a)(2), competitive bidding for this agreement is not practical or advantageous to the Department. Staff contacted other vendors that could provide similar services and had the necessary permits from the Mexican government to allow access to San Ignacio Lagoon; however, the vessels were smaller and had a limited passenger load that would have prevented the Cabrillo Marine Aquarium from conducting an adequate program. The Royal Polaris is the only sports fishing boat of adequate size and quality to comfortably accommodate the 39 passengers for the excursion and that had the necessary permits issued by the Mexican government to allow access to San Ignacio Lagoon.

The excursion starts from the Cabrillo Marine Aquarium. For a fee of \$2,375.00 per person, passengers will be transported to San Diego to board the Royal Polaris vessel and begin their nine-day whale watching and ecological tour. Passengers will explore the pristine coastal environments, diverse geological formations, and native vegetation of Baja. During the course of the trip, passengers may catch a glimpse of elephant seals, sea lions, dolphins, marine birds, and whales within camera range on board small motorized boats (skiffs) in San Ignacio Lagoon.

The 39 passengers include three Cabrillo Marine Aquarium staff and three volunteers who possess expertise in the fields of geology, botany, ornithology, and marine biology. The Team Leader for this trip will be the Cabrillo Marine Aquarium Program Director who will be assisted by the Aquarium's Education Curator. Cabrillo Marine Aquarium employees will be paid their normal salary and will be provided with food and accommodations throughout the nine-day trip. The volunteer experts will not receive financial remuneration, but will be provided room and board. In the event of last minute cancellations that cannot be filled from a waiting list of paying passengers, Cabrillo Marine will offer passage to Cabrillo Marine Aquarium staff or volunteers who can contribute an in-kind service or can cover the cost of their food and permits. Selection will be made by the Program Director and Aquarium Administrator.

A request for a Charter Section 1022 determination was submitted to the Personnel Department on July 9, 2009. It was determined that although the Department utilizes the classifications of Deck Hand, Boat Captain, and Port Pilot, the Department classifications do not require its incumbents to be Cardio Pulmonary Resuscitation (CPR) certified. Furthermore, the crew must have the ability to communicate in English and Spanish, have knowledge and expertise of the natural history of the area that will be visited in Mexico, navigational experience in the San Ignacio Lagoon, have United States Coast Guard Standards of Training Certification and Watchkeeping, and possess the excursion permit issued by the Mexican government. Based on the qualifications the Department is requesting of the crew, the City does not currently have any classifications that can perform the work. (See Attachment A)

The Department will pay Royal Polaris Sportfishing, Inc., an amount not to exceed \$59,940.00 for the nine-day whale-watching and ecological tour excursion. Additional expenses that would be incurred if the Department provided the Deck Hand, Boat Captain, and Port Pilot services for this trip include: boat rental, maintenance and operation, sleeper cabins, food and beverages for passengers, and small motorized boats for loading and unloading passengers, permits, and insurance coverage for the entire trip. Also, due to the temporary nature of the event, it would be necessary upon the whale-watching excursion and ecological tour's conclusion to layoff staff hired specifically for the event.

Royal Polaris Sportfishing, Inc., currently employs staff with the experience and expertise to provide the equipment and staff to perform the necessary services. Therefore, it is more feasible to contract out the services in order to ensure the needs of the public are met.

### FISCAL IMPACT STATEMENT:

Funds to pay for the charter are advances and reimbursed to Fund 301, Department 88, Municipal Recreation Program Account 035M. This program is self-sustaining in that the fees from the passengers offset the expense of the program. Cabrillo Marine Aquarium expects to recover all costs associated with this program. There is no impact on the Department's General Fund.

### **RECOMMENDATION:**

RATES AND FEES

That the Board approve an amendment to the Pershing Square section of the Department of Recreation and Parks' (Department) Schedule of Rates and Fees, as outlined in the attachment, effective upon Board approval.

### **SUMMARY**:

Pershing Square is a concert and event center in the heart of downtown Los Angeles comprising approximately five acres, with a maximum capacity of six thousand people. The Department conducts many programs, concerts and special events for the public at the site. Pershing Square is also a popular site for community events and rentals, and is in demand as a local filming location.

Following a review of the Department of Recreation and Parks' Schedule of Rates and Fees staff determined that the existing fees needed clarification and restructuring in order to better reflect the variety of programming, events and rentals requiring various levels and types of permits. Permit fees have not been adjusted since 2007.

Department staff have reviewed the Schedule of Rates and Fees for Pershing Square Park and recommend the changes submitted in order to clarify fees, more accurately recover Department costs, and generate new revenues. As the cost of providing services to the public continues to rise, the Department remains committed to providing quality and affordable recreational opportunities, and support services to the City's residents and visitors. Specific changes are identified in the attachment, new items identified by **bold** text and items proposed for deletion are indicated by strikeout text.

### FISCAL IMPACT STATEMENT:

The proposed amendments to the Schedule of Rates and Fees will provide additional revenue which will not impact the Department of Recreation and Parks General Fund (General Fund).

Fifty percent of the permit fees collected is deposited to the General Fund, and fifty percent to the facility account.

### **PERSHING SQUARE**

(Revised <del>07/07</del> 11/**09**)

Pershing Square Park is a concert and event center located in the middle of Downtown Los Angeles. The facility occupies an entire city block, is approximately five acres, and has a maximum occupancy of 6,000 people. With its unique fountain and amphitheatre it is a popular location for filming and special events.

Fifty percent (50%) of the fees will be deposited into the MRP account for Pershing Square Amphitheater and Fountain Area Park. The other 50% goes to the Department General Fund.

### FILM FEES

First two hours \$450.00

Each additional hour \$100.00

Maintenance/breakage fees \$600.00 (\$400.00 refundable if no damages)

Catering Fee \$250.00

Student Films \$50.00 4 hours maximum, one day only

Still photos \$100.00 every two hours, up to two hours (1 camera)

These fees are for the use of a portion of Pershing Square. You may choose the amphitheater (north) and/or fountain (south) end. Staff will determine additional costs for unique situations or activities. All fees must be paid in full at least 48 hours prior to permit. The Park Film Office must also be contacted.

### SPECIAL EVENT REQUIREMENTS

### **INSURANCE:**

Event holder must submit proof of insurance by a licensed carrier to the City Administrative Officer (CAO) of the City of Los Angeles at least seven days prior to the scheduled event. The insurance policy must meet all of the requirements specified by the CAO for such coverage.

PORTABLE SANITARY FACILITIES: Requirement meets Health Department Standards One (1) for every 200 (or fraction there of) participants

### SUMMARY:

To celebrate the 75<sup>th</sup> Anniversary of Muscle Beach, the Venice Recreation Center, Muscle Beach will bury a time capsule.
