COMMUNITY GARDENING PROGRAM

RECOMMENDATIONS:

That the Board:

- 1. Suspend the increase in community garden fees that was approved on July 14, 2010 through Board Report No. 10-180; and,
- 2. Direct staff to develop a comprehensive policy for community gardening and to return to the Board of Recreation and Park Commissioners for policy adoption.

SUMMARY:

On July 14, 2010, the Board of Recreation and Park Commissioners (Board) approved changes to the Department of Recreation and Parks' (RAP) schedule of rates and fees (Board Report No. 10-180). One of the fees modified in that schedule changed the annual fee for a community garden plot from \$25 per year to \$120 per year and applied that fee to nine community gardens within RAP.

On November 16, 2010, staff posted notice of a public meeting to discuss the approved increase in fees with community gardeners at each of the nine community gardens including, Eastside Community Garden, El Sereno Community Garden, Ocean View Farms, Orcutt Ranch Community Garden, Roger Jessup Community Garden, Rose Hills/Debs Community Garden, Sepulveda Garden Center, Solano Canyon Community Garden, and Wattles Farm. The meeting was held on November 23, 2010 and approximately 130 community gardeners attended.

At the December 8, 2010 Board meeting, the Board requested that staff return with a comprehensive report on the background and current operations of RAP's community gardening program.

Background

RAP has a long history with community gardens. Wattles Farm has served as a community garden since 1975, the permit to operate Ocean View Farms was issued in 1977, and community gardens were started at Orcutt Ranch approximately 25 years ago.

The chart below lists some basic information regarding the RAP's various community garden sites.

The operation of community gardens has traditionally been decentralized throughout RAP. RAP directly operates four community garden locations, which are the Sepulveda Garden Center located within the Sepulveda Basin, Orcutt Ranch, Little Green Acres, and the Rose Hills/Debs Community Gardens located within Debs Park. All other community garden locations are operated by an outside group or association on land that is either owned or leased by RAP. A Community Gardens Information Report is attached as Exhibit A and contains a detailed summary of the nine community garden locations.

Program Challenges

The challenge facing RAP is that there is no uniform set of pricing, policies or procedures for the various outside operators or associations operating the locations referenced above. Additionally, RAP provides varying levels of service and financial assistance at each location.

RAP has traditionally paid the cost of water at those locations where there is no separate water meter exclusive to the gardens. However, in some cases, outside operators or associations have paid the utilities fees. The level of services provided by RAP staff varies by location. For example, services range from no services at El Sereno Community Garden to a significant level of services including watering, weeding and rototilling at Sepulveda Garden Center.

The cost to the gardeners also varies by location. Prior to July 14, 2010, RAP charged gardeners at the Sepulveda Garden Center \$25 per year and those were paid directly to RAP. Gardeners who participate in programs operated by outside operators or associations do not pay fees directly to RAP, but rather to those organizations or associations operating the garden. Even among the outside operators and associations there is no uniform fee to participate in a community gardening program. For example, gardeners at the El Sereno Community Garden pay that operator \$50 per year, while gardeners at Ocean View Farms pay that operator \$30 per year plus \$6 for insurance.

The size of the plots, number of plots, number of participants, number of plots allowed per person, waiting list policies, etc. also vary by location and operator. Additionally, public access to the Community Gardens may be limited. The current model for the gardens is that, in order to prevent theft and vandalism, the gardens are fenced and locked with only community garden participants and their guests allowed physical access to the gardens.

Another issue which should be examined is the fees, if any, charged to community gardens that are not operated by RAP. A methodology for determining an appropriate fee, which is not program prohibitive, should be developed.

Uniform Policy Considerations

In order for the community gardening program to be standardized and become increasingly self-sufficient, RAP staff recommends the development of a uniform policy and a set of operating procedures for all community gardens. A uniform RAP policy would provide gardeners certainty in program operations regardless of who is operating the program. The development of a uniform community gardening policy would also facilitate the development of additional community gardening locations throughout the City, increasing the number of people who can participate in the program.

In order to develop policy for the program a detailed analysis of the actual costs to RAP should be performed. RAP, moving forward, should aim towards full cost recovery for all costs associated with the operation of community gardens. It may be that in order for RAP to continue to operate any of the community gardening locations the fees per person may need to be increased, or the level of services decreased, or in some cases both. Alternatively, RAP will further investigate the opportunity for partnerships and agreements with community gardening program operators.
