THE COMMISSION MAY MEET IN CLOSED SESSION IN CONNECTION WITH THIS ITEM TO CONFER WITH, OR RECEIVE ADVICE FROM, LEGAL COUNSEL REGARDING PENDING LITIGATION PURSUANT TO GOVERNMENT CODE SECTION 54956.9(B) (1) AND (3)(B). THE FACTS AND CIRCUMSTANCES ARE AS STATED IN THE BOARD REPORT, AND IN VARIOUS COMMUNICATIONS RECEIVED FROM LEGAL COUNSEL FOR SPOHN RANCH, INC., AND LEGAL COUNSEL FOR CALIFORNIA LANDSCAPE AND DESIGN, INC., DBA CALIFORNIA SKATEPARKS REGARDING THE BIDDERS AND THE BIDS FOR THIS PROJECT

The above item was described and presented to the Board by Neil Drucker, Project Manager III, Public Works, Engineering and Marcia Gonzales-Kimbrough, Deputy City Attorney. Thereafter, a hearing was conducted. Representatives from each party, California Landscape & Design, Inc., dba California Skateparks, and Spohn Ranch, Inc., were each given five minutes to address the Board and two minutes to provide rebuttal statements to the Board.

Deputy City Attorney Arletta Maria Brimsey, advised that the Board met in closed session in connection with this item to confer with, or receive

advice from, legal counsel regarding potential litigation based upon existing facts and circumstances and that there might be significant exposure to litigation against the City, despite representations by one of the parties that they have no intention of suing, pursuant to Government Code Section 54956.9(b) (1) and (3)(B). The facts and circumstances are as stated in the Board Report, and in various communications received from legal counsel for Spohn Ranch, Inc., and legal counsel for California Landscape and Design, Inc., dba California Skateparks regarding the bidders and the bids for this project.

A detailed discussion by the Commission ensued. Commissioner Stanley made a Motion to Approve Recommendation A of General Manager's Report No. 12-180. The motion made by Commissioner Stanley was seconded by Commissioner Werner. There being no objections, the motion was unanimously approved.

Councilmember Tony Cardenas, Council District 6, and Deputy City Attorney Marcia Gonzales-Kimbrough further addressed the Board on the item.

No request for public comment on this item was received.

At 10:50 a.m. President Sanders suspended the Special meeting and reconvened the regular meeting of the Board of Recreation and Park Commissioners.
