He further reported on the status of the Greek Theatre - Fourth Amendment to Concession Agreement No. 245 and the Amendment to the Griffith Park - Travel Town Museum Gift Shop Concession. reported that the golf food services concessionaires at Rancho Park, Hansen Dam, Los Feliz, Penmar, and Roosevelt agreed to enter into interim agreements; however, the food service concessionaire at Woodley Lakes Golf Restaurant did not agree to enter into an interim agreement with the Department.

Vice President Alvarez reported that the Task Force continued its discussions on the Department's Naming Policy.

- 3. Authorize the Chief Accounting Employee of Recreation and Parks to pay the settlement amount; and
- 4. Authorize the General Manager of Recreation and Parks, the City Attorney or his designee, or the Chief Accounting Employee of Recreation and Parks to make any technical corrections to the Agreement or payment as necessary to carry out the Board's intent.
