RESCISSION OF BOARD REPORT NO. 15-196 AND CONSIDERATION OF A REVISED PERSONAL SERVICES CONTRACT WITH HUGO E. PÉREZ FOR MARKETING, COMMUNITY OUTREACH AND OTHER SERVICES IN RELATION TO THE IMPLEMENTATION OF A DEPARTMENT-OPERATED YOUTH SOCCER PROGRAM AT VARIOUS RECREATION AND PARK FACILITIES

General Manager Michael A. Shull requested that the Board rescind its September 16, 2015 action which approved General Manager's Report No. 15-196 and the Personal Services Contract (Contract) with Hugo E. Pérez, and amended General Manager's Report No. 15-214 as follows:

The first sentence in the second paragraph of Page 4 shall state:

A number of soccer organizations are currently issued permits to conduct youth soccer league related activities at Department sites throughout the City.

The second sentence in the last paragraph of Page 4 shall state:

Additional sites may be added from time to time as needed, but will only be at Department run program sites.

General Manager Shull also amended the Scope of Services in the revised Contract to state the following:

18. Acknowledge and confirm that the Contractor is to work only with RAP organized and operated youth soccer programs. Contractor is not to work with other youth soccer organizations at RAP owned or operated sites. Contractor also agrees not to participate in, or work with any youth soccer program that will directly compete with any existing youth soccer organization permitted at RAP owned or operating sites.

Public comments were invited for General Manager's Report No. 15-214. Seven requests for public comment were received, and such comments were made to the Board.

Commissioner Sanford moved that General Manager's Report No. 15-214 be approved as amended. Commissioner Zuñiga seconded the Motion. There being no objections, the Motion was unanimously approved.

Cathie Santo Domingo, Superintendent of Planning, Construction and Maintenance Branch, corrected General Manager's Report No. 15-217 to reflect the addition of Algin Sutton Pool to the project list of new grant proposals for the re-opening of the Proposition K – L.A. for Kids Program 9th Funding Cycle Request for Proposals (RFP) as follows:

The first sentence in the fourth paragraph of Page 2 shall state:

In concurrence with the concerned Council Offices and RAP's Planning, Construction and Maintenance Branch staff, three (3) four (4) additional capital improvement projects have been identified for submission of proposals for the Proposition K 9th Cycle Proposition K competitive funds and two (2) previously submitted proposals are proposed to be revised and submitted.
