RECOMMENDATIONS

1. Approve the opening of the multi-stall restroom building at Horizon Avenue along Ocean Front Walk at Venice Beach for 24 Hour public access 365 days per year and should the Horizon Avenue restrooms be unavailable due to emergency circumstances, grant authorization to the General Manager or his designee to open an alternate multi stall restroom building at Venice Beach in order to continue serving the needs of the public;
2. Find that the proposed project does not constitute a "Project" subject to CEQA in accordance with Section 15378(b)(2) and (5) of the State CEQA guidelines; and
3. Authorize the Department of Recreation and Parks (RAP) staff to file a Coastal Development Permit (CDP) application, if required.

SUMMARY

The Venice Beach restrooms, under the current maintenance model, are open and cleaned several times per day, 365 days per year from 6:00 a.m. until approximately 10:30 p.m. RAP does not keep any restrooms open at any park after a park closes due to various concerns. These concerns include public safety, employee safety, increased vandalism, physical damage to the restroom facilities, increased criminal activity inside the facilities, and loitering. In order to open, maintain, and clean public restrooms overnight for an additional eight (8) hours in (1) one multi-stall restroom building, it requires additional labor, materials/supplies, and security resources. A budget request to fund the Venice Beach 24 Hour program was previously submitted and approved by the City Council. The approved funding is for one (1) full time employee, one (1) part time employee, custodial materials/supplies, and one (1) contract

security guard who will be present with RAP cleaning staff for an eight (8) hour shift overnight, 365 days/year.

On October 18, 2017, the Board of Recreation and Park Commissioners (Board) approved Report No. 17-227 (Attachment 1) that gave initial consideration of 24 Hour public restroom access to one multi stall restroom building at Venice Beach. Additionally, the Board considered, reviewed and approved the draft ordinance {Report No. R17-0131 (Attachment 1)} prepared by the City Attorney which would allow the Board to open one multi stall restroom building at Venice Beach at their discretion. The Board directed RAP staff to draft a report to the Arts, Entertainment, Parks and River Committee as well as the City Council seeking their approval of the ordinance. City Attorney Report No. R17-0131 contained the proposed ordinance which amended subsection "S" and added a new subsection "T" to Section 63.44 of the Los Angeles Municipal Code that would allow for the Board to open restrooms at Venice Beach at the Board's discretion. The new subsection "S" and the newly added subsection "T" in the ordinance states:

### **"S. Bathrooms, Locker Rooms and Changing Areas**

1. Notwithstanding Subsection B.14(b), the Board may allow 24-hour access to the restrooms at Venice Beach."

**"T. Severability.** If any portion, subsection, sentence, clause or phrase of this section is for any reason held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this section and each portion or subsection, sentence, clause and phrase herein, irrespective of the fact that any one or more portions, subsections, sentences, clauses or phrases be declared invalid."

At its meeting held Wednesday, November 29, 2017, the Arts, Entertainment, Parks & River Committee, recommended (Attachment 2) that the City Council approve the ordinance as outlined in City Attorney Report No. R17-0131.

At its meeting held Tuesday, December 12, 2017, the Information Technology Agency and General Services Committee concurred (Attachment 3) with the Arts, Entertainment, Parks and River committee and recommended that the City Council approve the ordinance as outlined in City Attorney Report No. R17-0131.

At its meeting held Wednesday, December 13, 2017, the City Council approved the ordinance (Attachment 4) providing the RAP Board the authority to open restrooms at Venice Beach for 24 Hour public access.

### ENVIRONMENTAL IMPACT STATEMENT

California Public Resources Code (PRC) § 21065 defines a “Project” subject to the California Environmental Quality Act (CEQA) as an activity which may cause a direct physical change in the environment, or a reasonably foreseeable indirect physical change in the environment. Section 15378(b)(2) of CEQA Guidelines states that a project does not include continuing, administrative or maintenance activities. In addition, Section 15378(b)(5) of CEQA Guidelines states that a project does not include organizational or administrative activities that will not result in direct or indirect physical changes in the environment. Therefore, Staff recommends that the Board find that the opening of a restroom at Venice Beach for 24 Hours consists of an administrative and organizational activity that will not result in direct or indirect physical changes to the environment, and thus is not a project subject to CEQA.

### FISCAL IMPACT STATEMENT

The funding required to maintain and operate one (1) multi-stall restroom building along Ocean Front Walk for expanded hours and allow for 24 Hour public access overnight for 365 days per year is currently within RAP’s General Fund budget. The available funding for FY 16-17 is Two Hundred Thirty-Four Thousand Dollars (\$234,000.00) and for FY 17-18 is Two Hundred Fifty-Five Thousand, Four Hundred Six Dollars (\$255,406.00).

RECOMMENDATIONS

- 1. Review and approve the draft ordinance (Report No. R17-0131)(Attachment 1) amending subsection "S" and adding a new subsection "T" to section 63.44 of the Los Angeles Municipal Code...
2. Direct the Department of Recreation and Parks' staff to file a Coastal Development Permit (CDP) application...
3. Direct the Department to present the draft ordinance to the Arts, Parks, River, Entertainment and Facilities Committee and to full City Council for further review and approval to adopt the proposed ordinance.

SUMMARY

Due to the increased population of homeless persons, at or near Venice Beach, Council District 11 as well as the Venice community expressed concern that there are no overnight public restrooms available for the homeless to use in the area thus causing a public safety and health concern.

The Venice Beach restrooms under the current maintenance model are open and cleaned several times per day, 365-days per year from 6:00 a.m. until approximately 10:30 p.m. The RAP typically does not keep any restrooms open at any park after a park closes due to various concerns. These concerns include public safety, employee safety, increased vandalism and physical damage to the restroom facilities, increased criminal activity inside the facilities and loitering. In order to open, maintain and clean public restrooms overnight for an additional eight (8) hours in (1) one multi-stall restroom building, it would require additional labor, materials/supplies and security resources.

Subsequent to Councilmember Bonin's motion, RAP staff identified the required funding necessary for the opening of one (1) multi-stall restroom building along Ocean Front Walk for expanded hours to allow for 24-hour public access, 365-days per year. A budget request to fund the program was submitted and approved by the City Council. The approved funding is for one (1) full time employee, one (1) part time employee, custodial materials/supplies and one (1) contract security guard who will be present with RAP cleaning staff for an eight (8) hour shift overnight, 365-days/year.

There is currently a City Attorney's Office draft ordinance pending which will require Arts, Parks, River, Entertainment and Facilities Committee as well as City Council approval. It is identified within City Attorney Report No. R17-0131, which amends subsection "S" and adds a new subsection "T" to section 63.44 of the Los Angeles Municipal Code which would allow for the Board of Recreation and Parks Commissioners to open restrooms at Venice Beach at the Board's discretion. The new subsection "S" and the newly added subsection "T" in the draft ordinance states:

### **"S. Bathrooms, Locker Rooms and Changing Areas**

1. Notwithstanding Subsection B.14(b), the Board may allow 24-hour access to the restrooms at Venice Beach.

**"T. Severability.** "If any portion, subsection, sentence, clause or phase of this section is for any reason held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this section and each portion of subsection, sentence, clause and phrase herein, irrespective of the fact that anyone or more portions, subsection, sentences, clauses or phrase be declared invalid."

**ORDINANCE NO. \_\_\_\_\_**

An ordinance amending Subsection S and adding a new Subsection T to Section 63.44 of the Los Angeles Municipal Code to allow the Board of Recreation and Parks Commissioners to open park restrooms at Venice Beach.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Subsection S of Section 63.44 of the Los Angeles Municipal Code is amended and the current Subsection S is relettered as Subsection T to read as follows:

**S. Bathrooms, Locker Rooms and Changing Areas.**

1. Notwithstanding Subsection B.14(b), the Board may allow 24-hour access to the restrooms at Venice Beach.

**T. Severability.** If any portion, subsection, sentence, clause or phrase of this section is for any reason held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this section and each portion or subsection, sentence, clause and phrase herein, irrespective of the fact that any one or more portions, subsections, sentences, clauses or phrases be declared invalid.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

## MOTION

The City recently adopted a Comprehensive Homeless Strategy (CHS) to address the severe crisis of homelessness in Los Angeles. Ultimately, the plan calls for providing significantly more affordable housing, permanent supportive housing, and rapid rehousing of the homeless. The CHS also recognizes that, over the next several years, while housing and resources are being created, there is a need for a "street strategy" that assists those living on the streets, and mitigates the impacts encampments and street living have on our residential neighborhoods and business districts.

One of the priorities identified for a street strategy in the CHS is the need to provide more access to public restrooms around the clock. Currently, people living on the streets have no access to public restrooms for large parts of the day. As a result, many people are forced to urinate and defecate outdoors. In Venice, many residents have reported finding human waste near or on their properties. In Venice, the situation is also exacerbated by the large number of tourists, who also have no access to restrooms during parts of the day.

The CHS Strategy 6F ("Expand Access to Public Restrooms") advises that the inability to address daily hygiene needs can exacerbate isolation experienced by homeless individuals and can further disconnect them from society by not allowing them to apply for housing or interview for a job. Additionally, denying restroom access to homeless individuals results in public health concerns as the streets and other public areas, by default, are used as hygiene facilities by individuals who have no other options.

Restrooms at Venice Beach are currently open from 6 a.m. to sometime between 9 p.m. and midnight, depending on cleaning schedules. Consistent with Council's adoption of the CHS and Strategy 6F, Expand Access to Public Restrooms, it would be prudent to determine what resources are needed to open the restrooms around the clock. It would also be prudent for City staff to determine whether other public restrooms could be opened at other city facilities, or whether temporary public restrooms could be installed at other locations.

I THEREFORE MOVE that the Council instruct the Department of Recreation and Parks to identify what financial and personnel resources would be required to open and maintain the public restroom facilities at Venice Beach around the clock.

I FURTHER MOVE that the Department of General Services survey City properties in Venice, and throughout Council District 11, to determine where additional restrooms facilities can be provided.



Motion instructs the Department of Recreation and Parks to identify the financial and staff resources required to open and maintain the public restroom facilities at Venice Beach 24 hours per day. Motion further directs the Department of General Services to identify other City-owned properties with bathrooms located in the 11th Council District than can be open for use by the public round the clock. Council referred Motion to the Arts, Parks, and River and the Entertainment and Facilities Committees for consideration. The referral was subsequently changed to the Arts, Entertainment, Parks, and River and the Information, Technology, and General Services Committees.

Accompanying a report to Council dated April 26, 2017, the City Attorney presents Ordinance amending Subsection S and adding a new Subsection T to Section 63.44 of the Los Angeles Municipal Code to allow the Board of Recreation and Parks Commissioners to approve 24-hour access to the restrooms at Venice Beach. On October 18, 2017, the Board of Recreation and Parks Commissioners approved the Ordinance. At its meeting held November 29, 2017, the Arts, Entertainment, Parks, and River Committee also recommended approval.

At its meeting held December 12, 2017, the Information, Technology, and General Services Committee recommended that Council approve the accompanying Ordinance, as recommended by the Board of Recreation and Parks Commissioners and the Arts, Entertainment, Parks, and River Committee.
