President Patsaouras requested a Motion to approve the Board Reports as presented, except for Board Report Nos 19-143, 19-144, 19-145, 16-146 which had technical corrections and 19-149, which was amended as noted above. It was moved by Commissioner Halper, seconded by Commissioner Diaz to approve the Board Reports as noted previously. There being no objections, the Motion was unanimously approved.

# **COMMISSION TASK FORCE UPDATES**

#### **Commission Task Force on Concessions Report**

Commissioner Diaz reported that the Task Force on Concessions did not meet.

# **Commission Task Force on Facility Repair and Maintenance**

Commissioner Halper reported that the Task Force on Facility Repair and Maintenance met and discussed the proposed Griffith Park 1933 Fire Memorial Plaque and the Griffith Park (3210 and 3258 Riverside Drive) - A Bridge Home Housing Project.

Commissioner Nicole Chase joined the Meeting.

#### GENERAL MANAGER'S REPORT AND VERBAL STAFF UPDATES

Anthony-Paul Diaz, Executive Officer and Chief of Staff, began his report by thanking Maintenance and Recreational staff for their continued work in making sure RAP facilities are operational and staffed during the summer heat season. Mr. Diaz also announced that he recently attended a meeting hosted by the City's Emergency Management Department to further prepare a plan and identify RAP's role during an emergency, such as the recent earthquakes. He shared that RAP facilities suffered some minor damage during the earthquake, but public use should not be impacted. Mr. Diaz then commented on RAP's ongoing partnership with LAFD in brush clearance and fire mitigation measures, particularly in CD 12 and CD 4. He announced that the Mayor's Office has created a Public Health Taskforce and RAP will have an integral role in identifying homeless encampments and possible public health hazards. Mr. Diaz shared that RAP recently re-opened Roosevelt Golf Course after a 9-month closure so that DWP could install "purple pipe" to help RAP meet the Mayor's water saving initiatives as well as allow RAP to redesign some of the golf course elements.

Mr. Diaz then asked Charles Singer, Superintendent, Valley Shoreline Region, to provide an update on the Various Communications received regarding the recent facility fee increase and its effect on organizations that use RAP facilities to operate their enterprise.

Mr. Diaz also called on Darryl Ford, Acting Superintendent of Planning and Construction, to provide an update on the process and community outreach procedures for possible capital improvement projects and partnership agreements.

Sondra Fu, Senior Management Aanlyst II, presented the Overview of the Adopted Fiscal Year 2019-20 Department of Recreation and Parks Operating Budget. Ms. Fu highlighted the major sources of revenue for RAP, such as the City's General Fund allocation and fees from facility use and services. She also described the expenditures RAP is expected to make to maintain operational and service levels throughout the City. Ms. Fu then broadcast RAP's workforce staff, broken down by old and new full-time positions, as adopted by the Board through a Board Report in a previous meeting.

#### **COMMISSION BUSINESS**

President Patsaouras requested and end-of-year update on the current season of Summer Night Lights and brief presentation of the fall version of this program. Commissioner Diaz requested an update on opportunities to recognize partners and sponsors and marketing plan for strategies with increased funding. Commissioner Chase requested a status update on RAP's Park Ranger program. Commissioner Halper requested an update on Potrero Canyon project.
