SUMMARY

North Hills Community Park is located at 8756 N. Parthenia in the east end of the North Hills Community of the City. This 4-acre property provides two synthetic soccer fields, parking lot, Community Center with staff office, restrooms and a Los Angeles Police Department stop in center. The property also offers parking, a play area, basketball courts, and benches for seating. An estimated 11,320 residents live within a 1/2 mile of North Hills. Due to the facilities, features, programs and services it provides, North Hills Community Park meets the standards for a community park as defined in the City's Public Recreation Plan.

PROJECT SCOPE

The proposed Project involves the demolition of the existing play equipment and surface and the installation of new play equipment and resilient surfacing, installation of a new trilogy gate, accessible path of travel which includes accessible signage, new parking lot stripping and curb cut, and replacement of damaged concrete along the south end of the playground. The Site Plan and Project Scope of Work is attached to this Report.

RAP staff estimates that the proposed Project will cost approximately Six Hundred Twenty-Five Thousand Dollars (\$625,000.00).

PROJECT FUNDING

Upon approval of this Report, Six Hundred Twenty-Five Thousand Dollars (\$625,000.00) in Quimby Fees can be transferred from the following accounts to the North Hills Community Park Account No. 89460K-NH and allocated to the proposed Project:

- Three Hundred Seventy-Six Thousand, Seven Hundred Seventy-Nine Dollars and Eighty-Four Cents (\$376,779.84) in Quimby Fees from the Mid-Valley Multipurpose Center Account No. 89460K-MM
- Twenty-One Thousand, Six Hundred Sixty Dollars (\$21,660.00) in Zone Change Fees from the Delano Recreation Center Account No. 89440K-DB
- Seventy-Four Thousand, Four Hundred Ninety-Six Dollars and One Cent (\$74,496.01) in Quimby Fees from the Andres and Maria Cardenas Recreation Center Account No. 89460K-BL
- Thirty-Nine Thousand, Seventy-Two Dollars and Sixty-Four Cents (\$39,072.64) in Quimby Fees from the Sepulveda Basin East Account No. 89460K-SF
- Sixteen Thousand, Fifty-Five Dollars and Eighty Cents (\$16,055.80) in Quimby Fees from the Sheldon Arleta Property Account No. 89460K-AV
- Three Thousand, Five Hundred Fifteen Dollars and Eighty-Two Cents (\$3,515.82) in Quimby Fees from the Sheldon Skate Park Account No. 89460K-XF
- Fifty- Four Thousand, Six Hundred Dollars (\$54,600.00) in Quimby Fees from the Tobias Avenue Park Account No. 89460K-TP
- Thirty-Eight Thousand, Eight Hundred Nineteen Dollars and Eighty-Nine Cents (\$38,819.89) in Quimby Fees from the Quimby Account No. 89460K-00

These Quimby Fees were collected within five (5) miles of North Hills Community Park, which is the standard distance for the allocation of the Quimby Fees for community recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3. FUNDING SOURCE MATRIX

PROJECT CONSTRUCTION

RAP staff has determined that sufficient funding has been identified for the construction of the proposed Project. Construction of the proposed Project is anticipated to begin in December 2019.

TREES AND SHADE

It is not anticipated at this time that the proposed Project will have any impact on existing trees or shade at North Hills Community Park

ENVIRONMENTAL IMPACT

The proposed Project consists of minor alterations to existing pathways, of removal and replacement of existing structures where the new structure will have substantially the same function, size and capacity, and of installation of accessory structures. As such RAP staff recommends that the Board of Recreation and Park Commissioners (Board) determine that it is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 1(3), 2(2) and 11(3) of the City CEQA Guidelines and Article 19, Section 15301(c), 15302(b) and 15311 of California CEQA Guidelines. An NOE will be filed with the Los Angeles County Clerk upon Board's approval.

FISCAL IMPACT

The authorization for the allocation of Quimby Fees to this Project will have no fiscal impact on RAP's General Funds.

The estimated costs for the design, development, and construction/installation of the proposed park improvements are anticipated to be funded by Quimby Fees or funding sources other than RAP's General Fund.

The maintenance of the proposed park improvements can be performed by the current RAP staff with no overall impact to existing maintenance services at this facility.


