2. Authorize the Department of Recreation and Parks' (RAP) Chief Accounting Employee to make technical corrections as necessary to carry out the intent of this Report, and prepare checks up to a total amount of \$1,650.00 (\$75.00 per project) to the Los Angeles County Clerk for the filing the NOEs for 22 Proposition 68 Statewide Park Program 2019 Round projects (Prop 68 Projects) as detailed in the attached Project list (Attachment No. 2).

SUMMARY

On June 5, 2018, Proposition 68 (Prop 68) was passed by a majority of California voters to fund a \$4.1 Billion "California Drought, Water, Parks, Climate, Coastal Protection, and Outdoor for All Act of 2018". The purpose of Prop 68 is to fund state and local parks, beaches, environmental protection and restoration, water infrastructure, and flood protection projects. A total of \$650.275 Million of Prop 68 funds have been dedicated to the Statewide Park Development and Community Revitalization Program (SPP).

On January 29, 2019, the State released the initial notice of funding availability for the Prop 68 SPP, which the state calls the "2019 Round", in the amount of \$254.942 Million to be awarded to communities across the State. This grant program competitively awards grants for the creation of new parks, boundary expansion and improvement of existing parks, or the renovation of recreation features at existing parks. Prop 68 SPP funding is limited to parks located in areas that either lack adequate park space of 3 acres per 1000 persons or have significant poverty with an average annual household level income below \$51,026. Prop 68 SPP 2019 Round applications were due August 5, 2019.

At the June 5, 2019 Board Meeting, the Board of Recreation and Park Commissioners (Board) approved RAP staff to submit various grant applications for the Prop 68 SPP 2019 Round (Report No. 19-097). Developed through robust community outreach, needs assessments, facility conditions, and Council Office recommendations, RAP staff presented the proposed Prop 68 SPP 2019 Round Project list to the Board for consideration. At its meeting on August 21, 2019, the Board approved the 23 proposed projects, scopes, and budgets as well as the grant resolutions (Attachment No. 1) (Report No. 19-165).

The Prop 68 SPP 2019 Round has a short grant performance period and strict liquidation date of June 30, 2022. As a result, the California State Department of Parks and Recreation Office of Grants and Local Services (State) has requested applicants to complete the environmental review process prior to grant award in order to better determine an applicant's capacity to complete the Prop 68 Project on time. As a requirement of the grant application, each Prop 68 Project needs to complete the environmental review process within 90 days of the grant

application deadline. In order to meet these requirements, RAP staff must file CEQA documentation for each project and submit it to the State by November 1, 2019.

RAP staff submitted a draft NOE with the grant application for the 20 Prop 68 Projects managed by RAP staff and the 2 Prop 68 Projects managed by RAP's non-profit partners, Los Angeles Neighborhood Land Trust (LANLT) and Los Angeles Neighborhood Initiative (LANI) (Attachment No. 2).

RAP is requesting that the Board approve the filing of an NOE with the Los Angeles County Clerk for the remaining 22 Prop 68 SPP Projects. This will allow RAP staff to meet the November 1, 2019 deadline and fulfill the requirements for the Prop 68 SPP grant application evaluation process.

TREES AND SHADE

Tree canopy coverage, new trees planted, and removal of trees will be addressed as project designs are brought back for Board consideration.

ENVIRONMENTAL IMPACT

Staff recommends that the Board determine that projects listed in the table below are exempt from the provisions of CEQA pursuant to the following class and categories of Article III, Section 1 of the City of Los Angeles CEQA Guidelines and the following sections of Article 19 of California State CEQA Guidelines.
