CONSIDERATION OF THE PARK FEE BOARD REPORTS

President Patsaouras requested a Motion to approve the Park Fee Board Reports, as presented. It was moved by Commissioner Chase, seconded by Commissioner Diaz to approve the Park Fee Board Reports as presented. There being no objections, the Motion was unanimously approved.

COMMISSION TASK FORCE UPDATES

Commission Task Force on Concessions Report

Commissioner Diaz reported that the Task Force on Concessions met and discussed several topics, among them, First and Broadway Park, staff is in negotiations with the bidder for the restaurant complex. The concept will be presented to the Task Force by the end of the year; Griffith Park Snack Stand RFP is expected to be released by the end of year; Sepulveda Driving Range, Food & Beverage is also expected to be released by end of year; and, for the Woodley Lakes, Harbor, and Hansen Dam Golf Course Restaurants, staff is developing an RFP for these golf courses as a package and bidders will also be able to bid on them separately.

She also stated that staff is working with the Rancho Park Golf Course incumbent and the new operator to coordinate a smooth transition. There should be a timeline in a couple of weeks; for the Griffith Golf Complex, it is expected that renovations will be completed the first quarter of 2020. After these renovations are completed, and as it is the same operator, renovations will also

begin at the Los Feliz Golf Course; the Penmar Golf Course renovation is expected to be completed in late 2019.

Commission Task Force on Facility Repair and Maintenance

Commissioner Halper reported that the Task Force on Facility Repair and Maintenance met and discussed the Holocaust Museum Conceptual Design Plans, along with further development at Pan Pacific Park to deal with the need to increase space and facilities for public use. This Task Force also discussed the 10-Minute Walk National Study Visit and related grant given to the City, of which Boyle Heights was the focus. The resulting study will show the relationship between various park facilities and how that will serve this community.

GENERAL MANAGER'S REPORT AND VERBAL STAFF UPDATES

General Manager, Michael A. Shull presented the General Manager's Report and began by introducing various staff to give an update on the Saddle Ridge Fire, beginning with Jimmy Kim, Superintendent of Operations, Emergency Management and Aquatics Division. Mr. Shull mentioned that RAP is the sheltering welfare arm as regulated by the City Charter, and spoke of the robust emergency operations division headed by Mr. Kim.

Mr. Kim introduced Sonya Young Jimenez, EPC II, and Brenda Aguirre, EPC I, who he said were the pillars of the RAP emergency management. As a matter of record, he read out all names of the emergency response team with their respective titles and assigned locations. He noted that these women and men serve as volunteers and perform above-and-beyond their daily recreational duties; and not only help coordinate and manage emergency responses, but also strengthen their commitment to training in order to improve and provide efficient services when that call comes. Mr. Kim noted that the Saddle Ridge fire started on Thursday, October 10, 2019 at 9:39 p.m. It began as a 15-acre fire, just off the 210 freeway and Yarnell exit, then within one hour the fire had jumped to a 60-acre fire. Currently the fire has affected the Sylmar area and is now 97% contained. This fire is expected to be 100% contained by Thursday, October 24th, depending on the red flag warnings.

Mr. Kim shared that RAP had two 24-hour operations and a one-day 12-hour support operation, which equates to five 12-hour shifts. The RAP staff Mr. Kim recognized were the ones operating the stations and coordinating this response. There were 15 EOC responders at every 12-hour shift, two (2) EOC responders at the Emergency Operations Center, ten (10) individuals staffing our Department Operation Center, and one (1) staff as our agency representative at the Unified Command Post that stationed at the Hansen Dam Sports Complex parking lot. At the peak of the activation, RAP had five shelters that were activated -- four were American Red Cross supported, and one was a fully RAP supported shelter. Just to note, all of these shelters, because of where the fire was, RAP staff set up all shelters before the American Red Cross arrived. Mr. Kim praised the efforts of his team. RAP staff also supported three (3) evacuation centers in the Valley, for a total of eight (8) sites. At the peak of the activation, Friday at 9 a.m., there were 325 residents in RAP shelters. Out of those eight (8) sites, three (3) of them were at full capacity.

RAP also hosted 59 pets, as the City is very pet friendly during emergency operations. Also, note that the Hansen Dam Equestrian Center is one of the RAP locations activated during emergency response to house larger animals. At peak response time, there are about 335 stalls available, and RAP staff supported 235 large animals. RAP also supported a firefighter shelter at Lake View Terrace -- that location just demobilized this past Saturday. The Firefighter Shelters are locations facilities for outside firefighters to sleep and get refuge. In addition, RAP also supported a local

assistance center, that opened up on Thursday, October 17th, and just closed on Tuesday, October 22, 2019, which presently has served over 50 families that lost homes and property.

Mr. Shull thanked Jimmy Kim and his staff for his efforts. Their efficiency makes the operation appear seamless, and this allows RAP to provide support at critical times. He stated that a few parks were closed for safety reasons, and reported that O'Melveny Park was hit hard. Mr. Shull mentioned that Jimmy Newson, who is a resident caretaker at O'Melveny Park, lost his home and possessions but fortunately he is safe because he was out of town.

Javier Solis, Superintendent of Maintenance, shared that RAP has just begun property damage assessment with State and County partners and that five parks sustained fire damages. These were the parks that were closed for safety reasons. At Stetson Ranch there were six trees that were damaged. RAP staff removed these trees, and the park is now open. Aliso Canyon had two trees that were damaged, crews removed these trees, and the park is now open. Bee Canyon had two trees that were damaged, crews removed these trees, and the park is now open. O'Melveny Park, suffered a lot of damage, 62 trees were damaged, and crews removed the trees. Also, there were pedestrian bridges have sustained some damage, and construction crews are there this morning to assess the damage. It is expected that those repairs will be completed shortly and the park should be open to the public by Friday morning. Linefield Canyon had 106 trees that were damaged. The forestry crews are there now and in the process of removing those trees. Mr. Solis noted that 80 percent of these trees are in undeveloped areas, meaning there is no irrigation and only survive on rainwater. The irrigated areas sustain about 20 percent of the trees. Most of these trees are within O'Melveny Park. He said that we are in process of working with partners and non-profits to replant these areas. Mr. Solis mentioned that RAP will be plantings cocoon plants in undeveloped areas, as this has been done before at Elysian Park, with a favorable success rate. In the irrigated areas, 15-gallon trees will be planted. These are standard size trees that are commonly used in other parks.

Mr. Shull asked Chief Park Ranger Joe Losorelli to say a few words regarding the loss of Park Ranger Captain Albert Torres, and provide information on funeral services. Chief Losorelli reported that Captain Torres had 45 years of City service. Captain Torres started his City career in 1974, then came to RAP in 1984. Captain Torres was a highly respected individual, and highly honored everywhere he went. This was a tremendous loss to our RAP family, and deepest condolences to his family. On the day he was hospitalized, he was working fire related response duty. He was on duty and in uniform when this happened. The rosary services will be on Sunday, October 27, 2019 at 5:00 p.m., at the Old North Church. Funeral service will be held on Monday, October 28, 2019 at 11:00 a.m., at Forest Lawn, Hollywood Hills. Over the last few days, RAP has received hundreds of cards from people all over the country, and from various fire departments. Captain Albert Torres will be greatly missed.

COMMISSION BUSINESS
