- 1. Approve the scope of work for the Baldwin Hills Recreation Center Fence Replacement (PRJ21348) Project (Project), as described in the summary of this Report;
- 2. Authorize the Department of Recreation and Parks (RAP) staff to commit from the following fund and work order numbers, a maximum of One Hundred Thousand Dollars (\$100,000.00) in Park Fees, for the Baldwin Hills Recreation Center Fence Replacement (PRJ21348) Project:

## <u>SUMMARY</u>

Baldwin Hills Recreation Center is located at 5401 Highlight Place in the Baldwin Hills community of the City. This 10.87-acre property provides a baseball diamond, indoor basketball courts, outdoor basketball courts, children's play area, picnic tables, and tennis courts for the use of the surrounding community. Due to the facilities, features, programs, and services it provides, Baldwin Hills Recreation Center meets the standard for a Community Park as defined in the City's Public Recreation Plan.

### PROJECT SCOPE

The proposed Project includes the replacement of the existing fence near the ball diamond.

### PROJECT CONSTRUCTION

RAP staff estimated the Project will cost approximate One Hundred Thousand Dollars (\$100,000.00). RAP staff has determined that sufficient funding has been identified and construction of the proposed Project is anticipated to begin in March 2020.

#### PROJECT FUNDING

Upon approval of this Report, One Hundred Thousand Dollars (\$100,000.00) in Park Fees can be committed to the Baldwin Hills Recreation Center – Fence Replacement (PRJ21348) Project.

These Park Fees were collected within five (5) miles of Baldwin Hills Recreation Center, which is the standard distance for the commitment of Park Fees for community recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3.

## ENVIRONMENTAL IMPACT

The proposed Project consists of the replacement of an existing structure which will be located on the same site as the structure replaced and have substantially the same purpose and capacity. As such, RAP staff recommends that the Board of Recreation and Park Commissioners determines that it is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 2 of City CEQA Guidelines and Article 19, Section 15302 of California CEQA Guidelines. An NOE will be filed with the Los Angeles County Clerk upon Board's approval.

# FISCAL IMPACT

The approval of this commitment of Park Fees for this Project will have no fiscal impact on RAP's General Fund.

The estimated costs for the design, development, and construction of the proposed park improvements are anticipated to be funded by Park Fees or funding sources other than the RAP's General fund. The maintenance of the proposed park improvements can be performed by current staff with no overall impact to existing maintenance service at this facility.
