SUMMARY

Green Meadows Recreation Center is located at 431 East 89th Street in the South Los Angeles community of the City. This 7.64-acre facility includes a baseball diamond, basketball courts, children's play area, indoor gym, swimming pool, and tennis courts. Approximately 13,038 City residents live within a one half mile walking distance of Green Meadows Recreation Center. Due to the facilities, features, programs, and services it provides, Green Meadows Recreation Center meets the standard for a Community Park, as defined in the City's Public Recreation Plan.

PROJECT SCOPE

The proposed Project will include the replacement of the HVAC system in the gymnasium building. The replacement of the HVAC system will not impact programming.

PROJECT FUNDING

Upon approval of this Report, Two Hundred Thirty Thousand Dollars (\$230,000.00) in Park Fees can be committed to the proposed Project.

These Park Fees were collected within five (5) miles of Green Meadows Recreation Center, which is the standard distance for the commitment of Park Fees for community recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3.

PROJECT CONSTRUCTION

RAP staff has determined that sufficient funding has been identified for the proposed Project and construction is anticipated to begin in March 2021.

TREES AND SHADE

The proposed Project will not have any impact on the existing trees and shade at Green Meadows Recreation Center.

ENVIRONMENTAL IMPACT

The proposed Project consists of replacement of existing heating and air-conditioning systems. As such, RAP staff recommends that the Board of Recreation and Parks Commissioners (Board) determines that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 2(6) of City CEQA Guidelines and Article 19, Section 15302 of California CEQA Guidelines. RAP staff will file a NOE with the Los Angeles County Clerk upon the Board's approval.

FISCAL IMPACT

The approval of this commitment of Park Fees will have no fiscal impact on the RAP's General Fund.

The estimated costs for the design, development, and construction of the proposed park improvements are anticipated to be funded by Park Fees or funding sources other than RAP's General Fund. The maintenance of the proposed park improvements can be performed by current staff with no overall impact to existing maintenance service at this facility.
