- 1. Accept the donation of two dog waste stations (depicted in Attachment 2 of this Report) and their installation and maintenance by the Hollywood United Neighborhood Council;
- Approve the placement of the dog waste stations, along with a recognition plaque as set forth in this Report, in the Lake Hollywood area of Griffith Park at the locations shown in Attachment 1 of this Report (Project);
- 3. Determine that the Project, consisting of the installation of small signs and placement of minor structures accessory to existing institutional facilities, is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 11(5) [Signs Located On City Property Managed By A City Department Which Has A Sign Policy Adopted By Its Board Of Commissioners] and Class 11(6) [Placement of minor structures accessory to existing institutional facilities] of City CEQA Guidelines and Article 19, Section 15311 of California CEQA Guidelines and direct Department of Recreation and Parks (RAP) staff to file a Notice of Exemption (NOE) with the Los Angeles County Clerk;

5. Allow RAP staff to make technical corrections as necessary in order carry out the intent of this Report.

#### SUMMARY

Griffith Park is located at 4730 Crystal Springs Drive in the Hollywood community of the City. This 4,281.73-acre park provides a wide variety of recreational programs and activities, such as train rides, a merry-go-round, hiking trails, and golf courses, for the local community. Approximately 18,155 residents live within a one-half mile walking distance of Griffith Park. Due to the facilities, features, and programs, and services it provides, Griffith Park meets the standard for a Regional Park, as defined in the City's Public Recreation Plan.

Lake Hollywood Park is located at 3160 North Canyon Lake Drive within Griffith Park. This 2.42- acre park has a children's play area, picnic table and open lawn. The Lake Hollywood Upper Vista area is located northeast of the Hollywood Reservoir and adjacent to Mulholland Highway.

In December 2020, the Hollywood United Neighborhood Council (HUNC) proposed the installation of dog waste stations in the Lake Hollywood section of Griffith Park. Lake Hollywood offers a scenic view of the Hollywood sign, and therefore is highly trafficked by many visitors and dog owners. Installing these dog waste stations would promote cleanliness within the park. The procurement, Installation and maintenance of these waste stations would be funded by the HUNC.

#### **SCOPE OF WORK**

The scope of work for the proposed Project includes the installation of two dog waste stations in Lake Hollywood Park. They will be located at the entrance of the park, as well as the far northeastern corner. A map of the proposed locations is attached to this Report (Attachment 1).

The waste stations will also include a small plaque in the approximate size of 3 inches X 6 inches reading "Donated by the Hollywood Hills United Neighborhood Council."

The Office of Council District 4 (CD 4) is in support of this proposed Project.

Letters of support from the Griffith Park Advisory Board, Lake Hollywood Homeowners Association, and CD 4 are attached to this Report (Attachment 2).

#### ENVIRONMENTAL IMPACT

The proposed Project consists of the installation of small signs and placement of minor structures accessory to existing institutional facilities. As such, RAP staff recommends that the Board of Recreation and Park Commissioners (Board) determines that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 11(5) and Class 11(6) of City CEQA Guidelines and Article 19, Section 15311

of California CEQA Guidelines. RAP Staff will file a Notice of Exemption with the Los Angeles County Clerk upon the Board's approval.

# FISCAL IMPACT

The acceptance of this donation will have no impact on RAP's General Fund. All installation and maintenance of the dog waste stations will be funded by the Hollywood United Neighborhood Council.



Lake Hollywood Homeowners Association (LHHA), Board of Directors met on October 20, 2020 to discuss supporting a community funded, installed, and managed lending library and dog waste stations at Lake Hollywood Park. RAP, CD4, HUNC and Universal Studios donated the financing to build and gate the playground, a picnic area and large grassy space that is located within Lake Hollywood Park. This is a popular space among local parents of the surrounding communities to bring their kids to play, socialize and get exercise separate from the rest of the park, dogs and outside visitors.
