RECOMMENDATIONS

- 1. Approve the scope of work for the Delano Recreation Center– Methane Gas Monitoring System Upgrades (PRJ21529) (PRJ21530) Project (Project), as described in the Summary of this Report;
- 2. Authorize Department of Recreation and Parks' (RAP) Chief Accounting Employee to transfer Seventy-Two Thousand, One Hundred Eight Dollars and Eighty-Nine Cents (\$72,108.89) in Quimby Fees from the Quimby Fee Account No. 89460K-00 to the Delano Recreation Center Account No. 89460K-DB;
- 3. Approve the allocation of Seventy-Two Thousand, One Hundred Eight Dollars and Eighty-Nine Cents (\$72,108.89) in Quimby Fees from the Delano Recreation Center Account No. 89460K-DB to the proposed Project;
- 4. Authorize RAP staff to commit from the following fund and work order numbers, a maximum of One-Hundred Twelve Thousand, Eight-Hundred Ninety-One Dollars and Eleven Cents (\$112,891.11) in Park Fees, for the proposed Project:

- 5. Approve the proposed Project to be bid and constructed through the RAP's list of prequalified on-call contractors;
- 6. Approve the authorization of change orders as authorized under Report No. 06-136, for the construction contracts for this proposed Project in the budget contingency amounts for such contracts as stated in this Report;
- 7. Determine that the proposed Project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 3(4) [Installation of new equipment involving negligible or no expansion of use required for safety, health, and environmental control] of City CEQA Guidelines and Article 19, Section 15303 of California CEQA Guidelines and direct RAP staff to file a Notice of Exemption (NOE) with the Loa Angeles County Clerk;

SUMMARY

Delano Recreation Center is located at 15100 West Erwin Street in the Van Nuys area of the City. This 4.45-acre facility provides a recreation center, auditorium, stage, synthetic soccer field, ball diamond, kitchen, children's play area, picnic tables for the surrounding communities. Approximately 6,307 City residents live within a one-half mile walking distance of Delano Recreation Center. Due to the facilities, features, programs, and services it provides, Delano Recreation Center meets the standard for a Community park, as defined in the City's Public Recreation Plan.

PROJECT SCOPE

The scope of the proposed Project includes the following:

- Removal of existing methane gas monitoring system.
- Installation of a new methane gas monitoring system.

PROJECT FUNDING

Upon approval of this Report, Seventy-Two Thousand, One Hundred Eight Dollars and Eighty-Nine Cents (\$72,108.89) in Quimby Fees can be transferred from Quimby Fee Account No. 89460K-00 to Delano Recreation Center Account No. 89460K-DB and allocated to the proposed Project.

Upon approval of this Report, One-Hundred Twelve Thousand, Eight-Hundred Ninety-One Dollars and Eleven Cents (\$112,891.11) in Park Fees can be committed to the proposed Project.

The total amount of funding available for the proposed Project is One Hundred Eighty-Five Thousand Dollars (\$185,000.00).

The anticipated pre-qualified on-call contracts will be for Park Facility Construction. The budget contingency for the Park Facility Construction Contract will be Fifteen Thousand Dollars (\$15,000.00).

These Quimby and Park Fees were collected within five (5) miles of Delano Recreation Center, which is the standard distance for the commitment of the Park Fees for community recreational facilities pursuant to Los Angeles Municipal Code (LAMC) Section 12.33 E.3.

PROJECT CONSTRUCTION

RAP staff has determined that sufficient funding has been identified and construction for the proposed Project is anticipated to begin in Winter 2021.

TREES AND SHADE

This proposed Project will have no impact on the existing trees and shade at Delano Recreation Center.

ENVIRONMENTAL IMPACT

The proposed Project consists of installation of new equipment involving negligible or no expansion of use required for safety, health, and environmental control.

This site is within a methane zone, and the installation of the proposed equipment has the goal to protect the users of the facility from methane infiltration. As far as other environmental resources of concern, the project is not in a coastal area or in an Historic Preservation Overlay Zone (HPOZ), nor it impacts on a recognized environmental resource of hazardous or critical concern, so there is no reasonable possibility that the project will have a significant effect due to its location or unusual circumstances. No other known projects would involve cumulatively significant impacts, and no future projects would result from the proposed project. As of October 8, 2021, the State Department of Toxic Substances Control (DTSC) (Envirostor at www.envirostor.dtsc.ca.gov) has not listed the Project site or any contaminated sites near the Project area (within 500 feet). According to the Caltrans Scenic Highway Map there is no scenic highway located within the vicinity of the project or within the project site. Furthermore, the project is not located in proximity of a known historical resources and will not cause a substantial adverse change in the significance of a historical resource.

As such, staff recommends that the Board determine that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 3(4) of City CEQA Guidelines and Article 19, Section 15303 of California CEQA Guidelines. Staff will file a NOE with the Los Angeles County Clerk upon Board's approval

FISCAL IMPACT

The approval of this commitment of Quimby Fees and Park Fees will have no fiscal impact on RAP's General Fund. The estimated costs for the design, development, and construction of the proposed park improvements are anticipated to be funded by Quimby and Park Fees or funding sources other than the RAP's General Fund. The maintenance of the proposed park improvements can be performed by current staff with no overall impact to existing maintenance service at this facility.
