#### SUMMARY

RAP staff recommends the transfer of appropriations in the amount of Two Hundred Fifty Thousand Dollars (\$250,000.00) from RAP to ITA for additional communication services ITA provides to RAP in Fiscal 2021-22. This transfer of appropriations would allow ITA to continue to provide various communication services to RAP by funding the replacement of equipment due to vandalism and installation of equipment for new projects.

RAP will reimburse ITA for the communication services provided up to the appropriated amount (\$250,000.00), when proper documentation is received.

#### FISCAL IMPACT

The appropriation of \$250,000 is needed in FY 2021-22 to support RAP's communication services needs.
