## SUMMARY

Westchester Recreation Center is located at 7000 West Manchester Avenue in the Westchester area of the City. This 23.79 acre facility provides baseball fields, basketball courts, a children's play area, a skate park, two gymnasiums, a senior center, and a swimming pool. Approximately Four Thousand Five Hundred Ninety Three (4,593) residents live within a one-half (1/2) mile walking distance of Westchester Recreation Center. Due to the facilities; features, programs, and services it provides, Westchester Recreation Center meets the standard for a Community Park, as defined in the City's Public Recreation Plan.

## PROJECT SCOPE

The scope of work for the proposed Project includes:

Refurbishment of the ballfields including, but not limited to, replacement of bleachers,

improvements to backstops and dug outs, improvements to irrigation systems, regrading and infill, installation of sod

- · Replacement of ballfield fencing
- Improvements to the path of travel
- Upgrades to the ballfield lighting
- Tree trimming and pruning

## PROJECT FUNDING

The Westchester Recreation Center Account No. 89440K-WR has a balance of Ten Thousand, Nineteen Dollars and Twenty Six Cents (\$10,019.26) in Zone Change Fees.

The Westchester Recreation Center Account No. 89460K-WR has a balance of Two Hundred Thirty Five Thousand, Three Hundred Fifty Two Dollars and Twenty Two Cents (\$235,352.22) in Quimby Fees.

Upon approval of this Report, Three Thousand, One Hundred Dollars and Eighty One Cents (\$3,100.81) in Zone Change Fees can be transferred from the Zone Change Account No. 89440K-00 to the Westchester Recreation Center Account No. 89440K-WR, and a total of Thirteen Thousand, One Hundred Twenty Dollars and Seven Cents (\$13,120.07) in Zone Change Fees can be allocated from the Westchester Recreation Center Account No. 89440K-WR to the proposed Project.

Upon approval of this Report, One Hundred Four Thousand, Eight Hundred Sixty Seven Dollars and Twenty Nine Cents (\$104,867.29) in Quimby Fees can be transferred from the Quimby Fees Account No. 89460K-00 to the Westchester Recreation Center Account No. 89460K-WR, and a total of Three Hundred Forty Thousand, Two Hundred Nineteen Dollars and Fifty One Cents (\$340,219.51) in Quimby Fees can be allocated from the Westchester Recreation Center Account No. 89460K-WR to the proposed Project.

Upon approval of this Report, One Million, Six Hundred Forty Six Thousand, Six Hundred Sixty Dollars and Forty Two Cents (\$1,646,660.42) in Park Fees can be committed to the proposed Project.

The total amount of funding available for the proposed Project is Two Million Dollars (\$2,000,000.00).

It is anticipated that RAP will utilize the Park Facility Construction, Electrical Construction, and Fence and Wall Installation, Repair and/or Maintenance on-call contracts in order to complete the proposed Project. The budget contingency for the Park Facility Construction contracts is One Hundred Thousand Dollars (\$100,000.00). The budget contingency for the Electrical Construction contract is One Hundred Thousand Dollars (\$100,000.00). The budget contingency for Fence and Wall Installation, Repair and/or Maintenance on-call contracts is Fifteen Thousand Dollars (\$15,000.00).

The Quimby, Zone Change and Park Fees were collected within five (5) miles of Westchester Recreation Center, which is the standard distance for the commitment of Park Fees for community recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3

## PROJECT CONSTRUCTION

RAP Staff has determined that sufficient funding has been identified for the Project and is anticipated to begin construction in Fall 2021.

## TREES AND SHADE

The proposed Project will have no impact on existing trees or shade. No new trees or shade are proposed to be added as a part of the Project.

### **ENVIRONMENTAL IMPACT**

The proposed Project consists of exterior alterations involving minor construction where there be negligible or no expansion of use; minor alteration of existing walkways; maintenance of existing landscaping; outdoor lighting for security and operations; replacement of existing structures and facilities where the new structure will be located on the same site and have substantially the same purpose and capacity as the structure replaced; grading on land with a slope of less than ten percent (10%); minor trenching and backfilling where the surface is restored. As such, staff recommends that the Board of Recreation and Park Commissioners (Board) determine that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 1(1), Class 1(3), Class 1(8), Class 1(12), Class 2, Class 4(1) and Class 4(12) of City CEQA Guidelines as well as to Article 19, Sections 15301, 15302, 15304(a) and 15304(f) of California CEQA Guidelines. Staff will file a Notice of Exemption with the Los Angeles County Clerk upon Board's approval.

## FISCAL IMPACT

The approval of this allocation of Quimby and Zone Change Fees and commitment of Park Fees will have no fiscal impact on RAP's General Fund. The estimated costs for the design, development, and construction of the proposed park improvements are anticipated to be funded by Quimby Fees, Zone Change Fees, Park Fees or funding sources other than RAP's General

Fund. The maintenance of the proposed park improvements can be performed by current staff with minimal impact to existing maintenance service at this facility
