REGULAR MEETING MINUTES

BOARD OF RECREATION AND PARK COMMISSIONERS OF THE CITY OF LOS ANGELES

Thursday, September 2, 2021

The Board of Recreation and Park Commissioners of the City of Los Angeles convened the telephonic Regular Meeting at 9:30 a.m. Present were President Sylvia Patsaouras, Vice-President Lynn Alvarez, Commissioners Tafarai Bayne, Nicole Chase, and Joseph Halper. Also present were Michael A. Shull, General Manager, Anthony-Paul Diaz, Executive Officer and Chief of Staff, Assistant City Attorney Mike Dundas, and Deputy City Attorney III Steven Hong.

CALL TO ORDER

APPROVAL OF THE MINUTES

President Patsaouras called for a motion to approve the minutes of the Regular Meeting of August 19, 2021. Commissioner Chase made such motion and it was seconded by President Patsaouras. There being no objections, the motion was unanimously approved by a vote of 5-0.

GENERAL PUBLIC COMMENTS

Public comments on matters within the Board's jurisdiction were invited, 10 such requests were submitted.

GENERAL MANAGER'S UPDATE

Michael A. Shull, General Manager, began his comments by sharing that RAP had over 36,000 registrations for summer camp programming, over 17,000 for youth sports programming, over 16,000 swim lessons were administered, over 2,500 aquatic team sports registrations, and over 1,300 participants in the signature judo and track and field programs. Mr. Shull thanked RAP's Recreation and Maintenance staff for working through the chlorine shortage challenges, and gave a shout-out to DWP for helping RAP meet its chlorine needs. He then stated that RAP will be offering extended pool hours on Saturdays and Sundays from 1-5 p.m., through the end of September. Mr. Shull announced that Mathews Park will have its groundbreaking ceremony on September 3rd, Venice Beach programming will ramp up and includes the Muscle Beach body building championships which will take place on Labor Day, Shane's Annual Inspiration Walk, Run & Roll event will take place on September 12th, Hansen Dam SunnySlope Baseball Fields will reopen September 12th with many improvements, Trinity Skate Park will open later in September. He then shared that RAP's Department Operations Center continues to be fully activated as the pandemic continues to affect the City. Mr. Shull also provided some background regarding RAP's role in addressing the homelessness crisis in the City.
