#### **CALL TO ORDER**

## **APPROVAL OF THE MINUTES**

President Patsaouras called for a motion to approve the minutes of the Regular Meeting of April 7, 2022. Commissioner Halper made such motion, and it was seconded by Commissioner Chase. There being no objections, the motion was unanimously approved by a vote of 3-0.

#### **GENERAL PUBLIC COMMENTS**

Public comments on matters within the Board's jurisdiction were invited, 10 such requests were submitted.

# **GENERAL MANAGER'S UPDATE**

Michael Shull, General Manager, began with thanking the staff of the Cabrillo Marine Aquarium on receiving their accreditation. Mr. Shull mentioned few recreation highlights. Mr. Shull stated that the Spring camp was a huge success with a 70 percent increase from last year. Mr. Shull mentioned that this past Saturday was the ending of the basketball camps which included over 1400 youths. Mr. Shull mentioned the registration for summer camp will begin on May 7, 2022.

Mr. Shull mentioned that we will be hosting the Summer Play LA launch at four locations on May 14, 2022, Expo, Lincoln Park, Van Ness and Hubert Humphrey It will include sports clinics and adaptive swimming and tennis. Mr. Shull mentioned we will be having a lifeguard recruit graduation on April 30, 2022. Mr. Shull mentioned an Earth Day event taking place at Griffith Park on Saturday April 23, 2022 at 8:30 a.m. There will also be an event from 1 p.m. to 3 p.m. at MacArthur Park. Mr. Shull mentioned there will be an Earth Day event at Sycamore Grove Park from noon until 6 p.m. on Sunday April 24th. Mr. Shull mentioned an event at Ascott Hills Park on

April 30, 2022 from 10 a.m. to 2 p.m. kite flying and tree give away. Mr. Shull mentioned an Earth Day event on Saturday April 30, 2022 at Tarzana Recreation Center.

Mr. Shull gave us a few highlights from the department's budget. The department received a 3 million dollar subsidy for summer camps. We received three new positions in the adaptive sports section. Mr. Shull mentioned that there was one concern on the budget requesting we generate 7 million in revenue.

There were three information reports presented to the Board: the status of the Department Logo, details of a City of Los Angeles Community Investment for Families Department Zoom meeting on May 4 for input on Housing & Community Development Funds, and a *Caliban's Hands* sculpture on display at Benny H. Potter Park until May 16 as part of an art tour.
