## CALL TO ORDER

## APPROVAL OF THE MINUTES

President Patsaouras called for a motion to approve the minutes of the Regular Meeting of December 16, 2021 and January 6, 2022. Commissioner Chase made such motion and it was seconded by Commissioner Halper with a correction to January 6, 2022 minutes.. There being no objections, the motion was unanimously approved by a vote of 5-0.

# **GENERAL PUBLIC COMMENTS**

Public comments on matters within the Board's jurisdiction were invited, four such requests were submitted.

### **GENERAL MANAGER'S UPDATE**

Michael Shull, General Manager, began his comments by addressing some of the comments and concerns that have been made from the public concerning the Griffith Park Pony rides. He stated that the department takes the concerns serious and let them know the department is in the process of evaluating that entire operation. Mr. Shull mentioned that he plans to come back to the Commission with some recommendations soon. He also addressed the concerns of the callers regarding the horse trails. He stated he is going to follow-up with our Maintenance staff to address the concerns of the horse trails. Mr. Shull mentioned that he is aware of the fence at the Wild life nature preserve. Mr. Shull plans to have some of the Contracts staff look into securing some funding to have the fence repaired.

Mr. Shull provided us with an update on COVID. He shared that the department of Recreation and Parks has had over 500 employees that have tested positive since December 21, 2021. He mentioned this has caused a significant impact on RAP staff. He mentioned that the good thing

was that he believes things are starting to plateau. Mr. Shull mentioned that the department has not been able to start most of its winter programs due to the surge in COVID. He stated the winter programs have been delayed until February 7, 2022, and that the department is accessing that operation weekly. He mentioned that RAP has decided to secure a number of large fans for quite a few of our Recreation centers which will circulate the air and add a layer of safety. He stated the fans will clear the air off basketball courts quickly. Mr. Shull stated hopefully we will be able to resume our basketball programs soon, but they are tentatively scheduled to resume on February 7, 2022. Mr. Shull mentioned that we did not have enough staff to open the Griffith Observatory last weekend. Mr. Shull stated we plan to open the Observatory this coming weekend.

Mr. Shull provided an update on the Community Schools program. He mentioned that Ryan Carpio is working on a Memorandum of Understanding with Los Angeles Unified School district. He mentioned both AGM Matthew Rudnick and Jimmy Kim have met and are working on a staffing plan to utilize the mobile Recreation plan. To begin hiring people for LA for kids' program in which he believes the community schools program will live, which will be under the direction of AGM Jimmy Kim. Mr. Shull mentioned that hopefully we will be able to utilize some of the funds from our agreement from the LA28 that RAP will be able to start doing some clinics at schools that do not have walkable access to parks.
