# **CALL TO ORDER**

# **APPROVAL OF THE MINUTES**

President Patsaouras called for a motion to approve the minutes of the Regular Meeting of March 3, 2022. Commissioner Chase made such motion, and it was seconded by Commissioner Halper. There being no objections, the motion was unanimously approved by a vote of 4-0.

# **GENERAL MANAGER'S UPDATE**

Michael Shull, General Manager, began with an update on the upcoming summer and the opportunities the department will have for hiring. He mentioned that we will be hiring for PlayLA instructors. Mr. Shull stated we plan to have a variety of new sports and fitness programs. Mr. Shull stated that we will be hosting a job fair at Mar Vista Recreation Center on Saturday, March 19, 2022 from 9:00 a.m. to 1:00 p.m. Mr. Shull stated that if you want to learn more about these job opportunities you may contact us at 213-485-8743 or visit laparks.org/jobs. He stated there will also be opportunities for camp counselors. Mr., Shull mentioned the department has plans to hire 200 more lifeguards for the summer season. There will be an open water test administered this Saturday, March 19, 2022 at Expo Center pool at 3900 Bill Robertson Lane. He stated there will be another opportunity on March 26, 2022 at the same location.

Mr. Shull mentioned the re-opening of Muscle Beach. He also mentioned an event we hosted at Algin Sutton pool on March 16, 2022 in which there was free swimwear attire giveaway. Mr. Shull

mentioned a health wellness and resource event being hosted this Friday, March 18, 2022 at San Julian Park. Mr. Shull mentioned the groundbreaking of Senator Bill Greene Park scheduled to take place on Saturday, March 26, 2022. Mr. Shull mentioned the Arbor day celebration scheduled to take place on Saturday, April 9, 2022 at Mount Carmel Recreation Center located at 830 West 70<sup>th</sup> Street, Los Angeles, CA 90044.

Assistant General Manager Jimmy Kim provided us with an update on Devonshire House. He stated the Devonshire House has several classes that are run by staff from the Northridge Recreation Center. He stated we also provide private and commercial use of the property. Mr. Kim stated that the Devonshire house is currently being used by the Boy scouts for meetings.

President Sylvia Patsaouras reported that the board must consider a determination, in accordance with AB 361 Section 3(e)(3) that, while the state of emergency due to the Covid-19 pandemic, as originally proclaimed by the Governor on March 4, 2020, remains active and/or state or local officials have imposed or recommended measures to promote social distancing, this legislative body has reconsidered the circumstances of the state of emergency and that the state of emergency continues to directly impact the ability of the members of this Board, and the ability of the members of all of this Board's advisory bodies, including, but not limited to, all park advisory boards, the Greek Theatre Advisory Committee, and the Golf Advisory Committee, as well as the public who might attend these meetings, to meet safely in person and/or state or local officials continue to impose or recommend measures to promote social distancing.

President Sylvia Patsaouras made motion for approval of such findings and Commissioner Bayne seconded the motion.
