REGULAR MEETING MINUTES

BOARD OF RECREATION AND PARK COMMISSIONERS OF THE CITY OF LOS ANGELES

Thursday, October 6, 2022

The Board of Recreation and Park Commissioners of the City of Los Angeles convened the telephonic Regular Meeting at 9:30 a.m. Present were, President Sylvia Patsaouras, Vice President Lynn Alvarez, Commissioners Tafarai Bayne, Nicole Chase and Joe Halper. CALL TO ORDER

APPROVAL OF THE MINUTES

President Patsaouras called for a motion to approve the minutes of the Regular Meeting of September 15, 2022. Commissioner Chase made such motion, and it was seconded by Commissioner Bayne. There being no objections, the motion was unanimously approved by a vote of 5-0.

<u>VERBAL REPORT AND FINDINGS TO CONTINUE TELECONFERENCING PURSUANT TO GOVERNMENT CODE SECTION 54953 (AB 361)</u>

President Sylvia Patsaouras reported that the board must consider a determination, in accordance with AB 361 Section 3(e)(3) that, while the state of emergency due to the Covid-19 pandemic, as originally proclaimed by the Governor on March 4, 2020, remains active and/or state or local officials have imposed or recommended measures to promote social distancing, this legislative body has reconsidered the circumstances of the state of emergency and that the state of emergency continues to directly impact the ability of the members of this Board, and the ability of the members of all of this Board's advisory bodies, including, but not limited to, all park advisory boards, the Greek Theatre Advisory Committee, and the Golf Advisory Committee, as well as the public who might attend these meetings, to meet safely in person and/or state or local officials continue to impose or recommend measures to promote social distancing.

President Sylvia Patsaouras made motion for approval of such findings and Commissioner Bayne seconded the motion. Public comment relevant to this item were invited, no such request was submitted. There being no objection to the motion, the motion was unanimously approved by a vote of 5-0.

GENERAL MANAGER'S UPDATE

Matthew Rudnick, Executive Officer, started with an Emergency Management update. Mr. Rudnick shared that the department has lifted its masking requirements in City Buildings and facilities, but masking is still strongly recommended. Mr. Rudnick stated that proof of vaccination is still a requirement in all City of Los Angeles Buildings.

Mr. Rudnick stated that our Maintenance Division plans to begin a pilot program, with new maintenance hours to address the concerns at high use park facilities. Mr. Rudnick mentioned that we have had several brush fires at our facilities, but most have been at Hansen Dam. He went on to thank the Park Rangers for their quick and effective response as well as their coordination with the Los Angeles Fire Department.

Mr. Rudnick shared several upcoming events and highlights, Saturday October 1st was the relaunch of the Community Schools program, he thanked the Commissioners who were in attendance.. Mr. Rudnick mentioned that our PlayLA and youth adaptive sports fall programs have begun. Mr. Rudnick stated on Saturday, October 8th the Westchester Recreation Center multipurpose field will reopen and there will be a groundbreaking ceremony at Lincoln Park to celebrate a new playground. He mentioned that on October 15th and 16th our gold division will be hosting a Senior Men's golf tournament at Wilson Harding Golf course. Mr. Rudnick stated the Griffith Observatory will now be open five days a week. On Saturday, October 22nd Griffith Park will celebrate P22 day and urban wild life day.

Edna Degollado shared a brief presentation on Youth Workforce Programs.
