#### **RECOMMENDATIONS**

- 1. Approve the installation of a mural at South Park Recreation Center as depicted in Attachment 3 of this Report for a length of five (5) years.
- 2. Determine that the project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 1(1) [Operation, repair, maintenance or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that previously exist] of City CEQA Guidelines and Article 19, Section 15301(a) of California CEQA Guidelines and direct Department of Recreation and Parks (RAP) staff to file a Notice of Exemption (NOE) with the Los Angeles County Clerk.
- 3. Authorize RAP's Chief Accounting Employee to prepare a check to the Los Angeles County Clerk in the amount of \$75.00 for the purpose of filing an NOE;
- 4. Authorize RAP to issue the appropriate Right-of-Entry (ROE) permits for the installation and maintenance of the mural.

5. Authorize RAP staff to make technical corrections as necessary to carry out the intent of this Report.

#### <u>SUMMARY</u>

South Park Recreation Center is located at 375 East 51st Street in the South Los Angeles community of the City. This 18.25-acre park features a gymnasium, swimming pool, basketball and tennis courts, a ball diamond and turf field, a synthetic turf field, an outdoor stage, outdoor fitness area, picnic tables, and children's play areas. Approximately 21,527 City residents live within a one-half mile walking distance of South Park Recreation Center.

The Department of Recreation and Parks (RAP) is in receipt of a Public Art Application, Art Waiver Form, and additional documentation from the organization Arts Bridging the Gap for the "Legacy" Mural that were provided on September 14, 2022. The Public Art Application and Artist Waiver are shown as Attachments 1 & 2, respectively.

The proposed mural installation at South Park Recreation Center would be on the Teen Center outside wall, as shown in the renderings in Attachment 3.

The mural was designed specifically for South Park Recreation Center by Ethel Zarinana and Amani Holbert, who both represent the diversity of the City of Los Angeles. Ethel Zarinana attended Loyola Marymount University and Antelope Valley College. Amani Holbert attended Loyola Marymount University and Digital Learning Academy. Both Zarinana and Holbert are based in Los Angeles. Both have previously worked on pieces of art in public spaces.

The proposed mural is dedicated to the youth of the area, the diversity of the area, and will display themes of "...peace, protest, play and the iconic palm trees that weave together the different communities of Los Angeles." The proposed mural aims to do this by having the community represented in designs they would like to see in the Mural. The youth of South Park Recreation Center's summer camp program participated in art workshops conducted by the muralists to help contribute to the design of the Mural. Two community meetings were held on August 3, 2022, and October 25, 2022, which are attached (Attachment 1) to gauge community feedback on the proposed design. The mural will not cover any doors or windows.

The office of Council District 9 has expressed support for the proposed mural.

#### MURAL FUNDING & MAINTENANCE

Arts Bridging the Gap (ABG) is collaborating with the City of Los Angeles Department of Civil + Human Rights and Equity in creating youth driven murals in South Park as part of the LA for All Campaign led by the Mayor's office. The mural will be paid for by funding secured by Arts Bridging the Gap and is estimated to cost Fifteen Thousand Dollars (\$15,000.00).

Woods Maintenance Services Inc., dba Graffiti Control systems will maintain the mural for its duration. ABG has an agreement with Woods Maintenance Services Inc., and thus ABG will be financially responsible for the maintenance of the mural (Attachment 5). The applicant has submitted a signed Waiver of Rights from both artists as part of the application process and RAP reserves the right to remove the mural if it is not maintained to RAP Standards. Anti-graffiti coating will be installed by Woods Maintenance Services Inc., dba Graffiti Control systems. The letter from ABG regarding mural maintenance is shown in Attachment 5.

#### MURAL APPROVALS

Arts Bridging the Gap presented the proposed mural to the Department of Cultural Affairs' (DCA) Cultural Affairs Commissions (CAC) on September 14, 2022, and the proposed mural received conceptual and final approval from the CAC.

On December 15, 2022, the proposed mural was presented to the RAP Facility Repair and Maintenance Commission Task Force (Task Force). The proposed mural was granted conceptual approval from the Task Force.

Upon approval of this Report, RAP staff will issue the appropriate Right-of-Entry (ROE) permits for the installation and maintenance of the mural at South Park Recreation Center.

#### **ENVIRONMENTAL IMPACT**

The proposed Project consists of minor alteration of existing public structures, involving negligible or no expansion of use beyond that previously existing.

According to the parcel profile report retrieved on January 6, 2023, this area resides in a liquefaction zone. The installation of the mural will not create conditions that could lead to liquefaction. This project is not within a coastal, historic, methane, hazardous waste, or bordering zone so there is no reasonable possibility that the project will have a significant effect due to unusual circumstances. No other known projects would involve cumulatively significant impacts, and no future projects would result from the proposed project. As of January 6, 2023, the State Department of Toxic Substances Control (DTSC) (Envirostor at www.envirostor.dtsc.ca.gov) listed an inactive site approximately 375 feet away from the project site (Case # 80001154). The State Water Resources Control Board (SWCB) (Geotracker at https://geotracker.waterboards.ca.gov/) has not listed the Project site or any contaminated sites near the Project area (within 500 feet).

According to the Caltrans Scenic Highway Map, there is no scenic highway located within the vicinity of the project or within the project site. Furthermore, the project is not located in proximity of a known historical resources and will not cause a substantial adverse change in the significance of a historical resource.

Based in this information, RAP staff recommends that the Board determines that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 1(1) of City CEQA Guidelines and Article 19, Section 15301(a) of California CEQA Guidelines. Staff will file a Notice of Exemption with the Los Angeles County Clerk upon Board's approval.

#### **FISCAL IMPACT**

The approval of this Report will have no fiscal impact on RAP's General Fund as costs for the installation and maintenance of the mural will be the responsibility of Arts Bridging the Gap.

Arts Bridging the Gap is excited to partner with The Los Angeles Mayor's Department of Human and Civil rights and Equity in creating a youth driven mural in South Park part of the LA for All Campaign led by the Mayor's office. A primary goal of this project is to create a mural on a prominent public wall in a way that is meaningful for the community, providing an uplifting outlook for the future and celebrating the legacy of their past. The design was created as a collaboration between the two selected muralists - one African American, one Latina and the youth at South Park's summer camp. Arts Bridging the Gap and the muralists conducted art workshops including games, discussions, and artmaking. This allowed for free expression and thought-provoking understandings, so that the muralists could see through the communities' eyes and gain a deeper perspective on how to make a public art piece meaningful for everyone in the neighborhood. In addition to working with the youth, Arts Bridging the Gap also spoke with adult community members about the history of the park to infuse this into the art piece. Themes of renewal and fun were highlighted by the youth and the adult community members expressed imagery relating to the evolution and legacy of the park. South Park has a history of many faces. From being a place of turbulent tension to a place of peaceful protest, it has held space for the vast spectrum that is the human experience of living in community. Although the older members of the community still see the scars of the park, the youth maintain the park's purity and innocence as they treat it as a place for their spirits to play freely. This piece aims to showcase South Park's vibrant ever-evolving legacy by depicting moments of peace, protest, play and the iconic palm trees that weave together the different communities of Los Angeles.

### ARTIST TEACHING AGREEMENT STREET ART INITIATIVE

This Muralist Agreement ("Agreement") is entered into as of [Friday, July 29, 2022] ("Effective Date"), by and between ARTS BRIDGING THE GAP, a nonprofit corporation (hereinafter, "ABG"), and [Ethel Zarinana], an individual (hereinafter, the "Artist"). ABG and the Artist are hereafter together referred to as the "Parties" and each individually as a "Party."

- A. WHEREAS, ABG is a nonprofit corporation which seeks to highlight the voices, experiences, and self-expression of youth from under resourced communities through immersive arts programs.
- B. WHEREAS, ABG coordinates several programs which aim to engage young artists and communities as a whole towards interaction, self-expression, and cooperation.
- C. WHEREAS, ABG administers a "Street Art Initiative" program (the "Program"). The Program connects muralists to locations in Southern California seeking the design of murals by artists in conjunction with student groups related to community, connectedness, collaboration, and social change.
- D. WHEREAS, the Artist has expertise and specialized knowledge in the composition and production of artwork, and in interacting with the public, including children and adults.
- E. WHEREAS, ABG desires to contract with the Artist, and the Artist desires to design a mural ("Mural") based on the materials provided by ABG ("Materials") for installation on or about [September 2022] ("Installation Date") at [South Park Recreation Center, 345 E 51st St, Los Angeles, CA 90011] ("Mural Location").

NOW, THEREFORE, in consideration of the agreements, covenants and conditions contained herein, the Parties hereby agree as follows:

#### 1. TERM AND TERMINATION OF AGREEMENT

- 1.1 <u>Term.</u> This Agreement shall be in full force and effect as of the Effective Date and shall terminate upon cancellation or termination as set forth herein. This Agreement shall have no effect on separate agreements entered into by the Parties with respect to other services (including but not limited to any murals conducted by the Artist in coordination with ABG).
- 1.2 <u>Termination</u>. Unless otherwise terminated, revised, or extended as set forth herein, this Agreement shall begin on the Effective Date and shall terminate when all agreements are met after installation date.
- 1.3 <u>Early Termination by ABG</u>. If ABG determines, in its reasonable discretion that it no longer desires for the Artist to design the Mural, the Parties shall mutually agree on the appropriate fee, if any, to be paid to the Artist for work already completed on the Mural design in proportion to the Contract Sum, prior to such date that ABG informs the Artist

- of its desire to terminate this Agreement prior to completion of the Mural design. If the Artist is in breach of this Agreement, the artist shall not be entitled to any compensation.
- 1.4 <u>Early Termination by the Artist</u> The Artist may terminate this Agreement with or without cause, by delivering to ABG written notice at least seven (14) days prior to the Installation Date. In the event the Artist terminates the Agreement pursuant to this Section 1.4, the Artist shall not be entitled to any compensation hereunder, including for any Mural design work actually completed.

#### 2. ARTIST RIGHTS, OBLIGATIONS AND REPRESENTATIONS

2.1 Services. The Artist shall timely perform the services agreed upon in a separate writing between the Artist and Program Manager (collectively, "Services"). The Program Manager is ABG's Program Manager or their designee ("Program Manager"). ABG may unilaterally change the name of the Program Manager by providing notice to the Artist in writing.

The Services include the following:

- The Artist shall design a Mural incorporating the materials provided by ABG.
- The Artist shall submit to the Program Manager a rendering of the Mural at the
  deadline agreed upon in writing by the Program Manager and Artist. For clarity,
  "in writing" for the purposes of this Agreement shall mean via physical or digital
  written format, including but not limited to email, text message, or physical
  writing.
- ABG, in its reasonable discretion, shall approve, deny, or suggest revisions in writing and the Artist is responsible for making revisions on an agreed upon deadline in writing with the Program Manager.
- If agreed upon by the Project Manager and the Artist in writing, the Artist shall
  participate in painting the Mural at the Mural Location on the Installation Date.
- ABG and the Artist will agree in writing on required materials that fit within the budget. ABG will provide such materials.
- The Artist shall regularly respond to and communicate with ABG through email, text, or phone and participate in virtual meetings during this entire process outlined above.
- 2.2 Decorum, Standard of Performance. The Artist represents and warrants that they are experienced in performing the Services contemplated herein and is experienced in working with both minors and adults. The Artist shall use their professional judgment to perform the Services required pursuant to this Agreement in the manner and according to the standards observed by a competent artist. Without limiting the foregoing, the Artist agrees to conduct themselves when performing the Services in a manner which is culturally competent and sensitive considering the community surrounding the Mural Location. The Artist shall not conduct any training required by ABG while under the influence of drugs or alcohol.
- 2.3 <u>Compliance with Laws</u>. The Artist shall comply with all applicable local, state, and federal laws and regulations applicable to the performance of the Services hereunder. The Artist

shall be solely responsible for compliance with this Section and shall indemnify ABG for any violation of the applicable laws, including but not limited to copyright laws. The Artist shall cooperate with ABG to the extent ABG requires information from the Artist to comply with ABG's legal obligations, including but not limited to reports to the California Employment Development Department (EDD).

2.4 <u>Assumption of Risk of Property Loss.</u> To the greatest extent permitted by law, the Artist hereby assumes, and waives and releases ABG and all of its officers, agents, and employees from, any and all risk of loss and damage to the Artist property due to fire, theft, rain, water overflow/leakage, acts of God, inadequate security, and any other cause occurring in connection with the Artist's performance of the Services.

#### 2.5 Indemnification.

- 2.5.1 The Artist shall indemnify, protect, defend (with counsel selected by ABG), and hold harmless ABG, and any and all of its officers, employees, volunteers, and agents from and against any and all claims, losses, costs, damages, expenses, liabilities, liens, actions, causes of action (whether in tort, contract, under statute, at law, in equity, or otherwise) charges, awards, assessments, fines, or penalties of any kind (including reasonable consultant and expert fees and expenses of investigation costs of whatever kind and nature and, if the Artist fails to provide a defense for ABG, the legal costs of counsel retained by ABG) and any judgment (collectively, "Claims"), where the same arise out of, are a consequence of, or are in any way attributable to, in whole or in part, the performance of this Agreement by the Artist or by any individual or entity for which the Artist is legally liable, including but not limited to officers, agents, employees, subcontractors of the Artist.
- 2.5.2 Without limiting Paragraph 2.6.1 herein, the Artist shall specifically indemnify ABG for Claims arising out of alleged copyright, trademark, or other rights of third parties with regard to the artwork created pursuant to the Services.
- 2.5.3 The provisions of this Section do not apply to claims occurring as a result of ABG's sole or active negligence. The provisions of this Section shall not release ABG from liability arising from gross negligence or willful acts or omissions of ABG or any and all of its officers, employees, and agents acting in an official capacity.

#### 2.6 Work Product.

2.6.1 Right to and Use of Mural Design. The Artist will retain the rights, title, ownership of, interest in, and claim to the Mural, and use thereof by ABG or any third party. The Artist hereby grants a perpetual, non-exclusive, fully paid, non-transferable, royalty-free license to access, use, modify, copy, adapt, display, publish and create derivative works of, any photograph or digital representation of the Artist and/or Mural in any non-commercial or fundraising brochures, internet site or other publication in all media (including electronic and digital). The Artist and the owner of the property on which the Mural is to be located shall independently execute a

- separate agreement which shall provide that the Artist shall waive its rights to the Mural after two (2) years. ABG shall maintain the Mural for a period of two (2) years, and the Artist acknowledges that the license granted to ABG pursuant to this Paragraph expressly permits ABG to maintain the Mural.
- 2.6.2 <u>Copyright</u>. The Artist shall retain copyright of the Mural. The Artist grants permission to ABG to use the mural image in products in order to fundraise for ABG's mission. The Artist understands that this includes reproduction, adaptation, publication, and display. The Artist represents and warrants that it shall not make any claim to the copyright of the Artwork and/or Mural against ABG or against any ABG employee, representative, officer, official, agent, or volunteer.
- 2.7 <u>Media</u>. The Artist may publish on social media regarding their participation in the Program provided that the Artist mentions that such participation is conducted in cooperation with ABG and the Program.
- 2.8 Independent Contractor. The Artist is and will remain throughout the Term, an independent contractor. The Artist is not and will not become an employee, partner, or principal of ABG, and the Artist agrees that they are not entitled to the rights or benefits afforded to ABG's employees, including disability or unemployment insurance, workers' compensation, medical insurance, sick leave, or any other employment benefits. The Artist does not, and will not, stand in a fiduciary capacity with ABG. The persons performing the Services under this Agreement on behalf of the Artist shall at all times be under the Artist's exclusive direction and control. The Artist shall not incur or have the power to incur any debt, obligation, or liability whatever against ABG, or bind ABG in any manner. Subject to the terms and conditions of this Agreement, the Artist may represent, perform services for, and contract with additional clients, persons, or companies as the Artist, in their sole discretion, deems prudent.
- Use of Employees, Agents, Volunteers, or Subcontractors, Assignment. The Artist may use or employ subcontractors or others working on the Artist's behalf to perform the Services, upon twenty-four (24) hours' written notice to the Program Manager. The Artist shall remain solely responsible for compliance with this Agreement and must ensure that all persons working on behalf of the Artist comply with all the terms hereunder in connection with the Services. This Agreement may not be assigned without written agreement by both Parties.

#### 3. COMPENSATION

3.1 Contract Sum. ABG's compensation rates are set to compensate artists in a manner aligned with ABG's view of the importance of the arts to community, unity, and growth. The total compensation for the Services is, and shall not exceed [\$3500] ("Contract Sum"). Unless otherwise set forth herein, ABG shall not be required to pay to the Artist any additional sum to the Contract Sum. ABG shall supply all required materials such as but not limited to, paint and scaffolds, agreed upon in writing by the Program Manager after discussing what is needed with the Artist. In no event shall ABG be required to reimburse the Artist.

- for materials or supplies purchased by the Artist, unless such reimbursement is authorized in advance and in writing by the Program Manager.
- 3.2 <u>Payment</u>. The Artist shall notify the Program Manager in writing when the Mural design is finalized after any agreed upon revisions. ABG will pay a deposit to the Artist of fifty percent (50%) of the Contract Sum after the design is approved and finalized. The Artist shall contact the Program Manager when the Mural installation is complete. Upon ABG's confirmation that the Artist has completed the Services to ABG's reasonable satisfaction, ABG shall pay the Contract Sum to the Artist within seven (7) days.

#### 4. MISCELLANEOUS

- 4.1 <u>Survival</u>. All obligations arising prior to the expiration or termination of this Agreement and all provisions of this Agreement allocating liability between the Artist and ABG shall survive the expiration or termination of this Agreement.
- 4.2 <u>Applicable Law; Venue.</u> The internal laws of the State of California shall govern the interpretation and enforcement of this Agreement. In the event that either Party brings any action against the other under this Agreement, the Parties agree that trial of such action shall be vested exclusively in Los Angeles County.
- 4.3 <u>Severability</u>. If any provision of this Agreement is held invalid, the remainder of this Agreement shall not be affected thereby, and all other parts of this Agreement shall nevertheless be in full force and effect.
- 4.4 <u>No Implied Waiver of Breach</u>. The waiver of any breach of a specific provision of this Agreement does not constitute a waiver of any other breach of that term or any other term of this Agreement.
- 4.5 <u>Counterparts</u>. This Agreement may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
- 4.6 No Third-Party Beneficiaries. There are no intended third-party beneficiaries under this Agreement and no such third parties shall have any rights or obligations hereunder.
- 4.7 <u>Limitation of Liability</u>. To the fullest extent permitted by law, ABG shall have no liability with respect to ABG's obligations under this Agreement or otherwise for consequential, exemplary, special, incidental, or punitive damages even if ABG has been advised of the possibility of such damages.
- 4.8 <u>Amendment, Termination</u>. This Agreement shall not be amended or terminated without prior written consent of both the Artist and ABG. The Program Manager is duly authorized to amend the Agreement on behalf of ABG.
- 4.9 <u>Attorneys' Fees</u>. If any legal action, including arbitration or an action for declaratory relief, is brought to enforce or interpret the provisions of this Agreement, the prevailing Party shall be entitled to recover reasonable attorneys' fees from the other Party. These fees, which may be set by the court in the same action or in a separate action brought for that

purpose, are in addition to any other relief to which the prevailing Party may be entitled. This provision applies to the entire contract; and each Party to this contract was represented by an attorney in the negotiation and execution of the Agreement.

If ABG determines, in its reasonable discretion that it no longer desires for the Artist to design the Mural, the Parties shall mutually agree on the appropriate fee, if any, to be paid to the Artist for work already completed on the Mural design in proportion to the Contract Sum, prior to such date that ABG informs the Artist

- of its desire to terminate this Agreement prior to completion of the Mural design. If the Artist is in breach of this Agreement, the artist shall not be entitled to any compensation.
- 1.4 Early Termination by the Artist The Artist may terminate this Agreement with or without cause, by delivering to ABG written notice at least seven (14) days prior to the Installation Date. In the event the Artist terminates the Agreement pursuant to this Section 1.4, the Artist shall not be entitled to any compensation hereunder, including for any Mural design work actually completed.

#### 2. ARTIST RIGHTS, OBLIGATIONS AND REPRESENTATIONS

2.1 Services. The Artist shall timely perform the services agreed upon in a separate writing between the Artist and Program Manager (collectively, "Services"). The Program Manager is ABG's Program Manager or their designee ("Program Manager"). ABG may unilaterally change the name of the Program Manager by providing notice to the Artist in writing.

The Services include the following:

- The Artist shall design a Mural incorporating the materials provided by ABG.
- The Artist shall submit to the Program Manager a rendering of the Mural at the
  deadline agreed upon in writing by the Program Manager and Artist. For clarity,
  "in writing" for the purposes of this Agreement shall mean via physical or digital
  written format, including but not limited to email, text message, or physical
  writing.
- ABG, in its reasonable discretion, shall approve, deny, or suggest revisions in writing and the Artist is responsible for making revisions on an agreed upon deadline in writing with the Program Manager.
- If agreed upon by the Project Manager and the Artist in writing, the Artist shall
  participate in painting the Mural at the Mural Location on the Installation Date.
- ABG and the Artist will agree in writing on required materials that fit within the budget. ABG will provide such materials.
- The Artist shall regularly respond to and communicate with ABG through email, text, or phone and participate in virtual meetings during this entire process outlined above.
- 2.2 <u>Decorum, Standard of Performance</u>. The Artist represents and warrants that they are experienced in performing the Services contemplated herein and is experienced in working with both minors and adults. The Artist shall use their professional judgment to perform the Services required pursuant to this Agreement in the manner and according to the standards observed by a competent artist. Without limiting the foregoing, the Artist agrees to conduct themselves when performing the Services in a manner which is culturally competent and sensitive considering the community surrounding the Mural Location. The Artist shall not conduct any training required by ABG while under the influence of drugs or alcohol.
- 2.3 <u>Compliance with Laws</u>. The Artist shall comply with all applicable local, state, and federal laws and regulations applicable to the performance of the Services hereunder. The Artist

shall be solely responsible for compliance with this Section and shall indemnify ABG for any violation of the applicable laws, including but not limited to copyright laws. The Artist shall cooperate with ABG to the extent ABG requires information from the Artist to comply with ABG's legal obligations, including but not limited to reports to the California Employment Development Department (EDD).

2.4 <u>Assumption of Risk of Property Loss</u>. To the greatest extent permitted by law, the Artist hereby assumes, and waives and releases ABG and all of its officers, agents, and employees from, any and all risk of loss and damage to the Artist property due to fire, theft, rain, water overflow/leakage, acts of God, inadequate security, and any other cause occurring in connection with the Artist's performance of the Services.

#### 2.5 Indemnification.

- 2.5.1 The Artist shall indemnify, protect, defend (with counsel selected by ABG), and hold harmless ABG, and any and all of its officers, employees, volunteers, and agents from and against any and all claims, losses, costs, damages, expenses, liabilities, liens, actions, causes of action (whether in tort, contract, under statute, at law, in equity, or otherwise) charges, awards, assessments, fines, or penalties of any kind (including reasonable consultant and expert fees and expenses of investigation costs of whatever kind and nature and, if the Artist fails to provide a defense for ABG, the legal costs of counsel retained by ABG) and any judgment (collectively, "Claims"), where the same arise out of, are a consequence of, or are in any way attributable to, in whole or in part, the performance of this Agreement by the Artist or by any individual or entity for which the Artist is legally liable, including but not limited to officers, agents, employees, subcontractors of the Artist.
- 2.5.2 Without limiting Paragraph 2.6.1 herein, the Artist shall specifically indemnify ABG for Claims arising out of alleged copyright, trademark, or other rights of third parties with regard to the artwork created pursuant to the Services.
- 2.5.3 The provisions of this Section do not apply to claims occurring as a result of ABG's sole or active negligence. The provisions of this Section shall not release ABG from liability arising from gross negligence or willful acts or omissions of ABG or any and all of its officers, employees, and agents acting in an official capacity.

#### 2.6 Work Product.

2.6.1 Right to and Use of Mural Design. The Artist will retain the rights, title, ownership of, interest in, and claim to the Mural, and use thereof by ABG or any third party. The Artist hereby grants a perpetual, non-exclusive, fully paid, non-transferable, royalty-free license to access, use, modify, copy, adapt, display, publish and create derivative works of, any photograph or digital representation of the Artist and/or Mural in any non-commercial or fundraising brochures, internet site or other publication in all media (including electronic and digital). The Artist and the owner of the property on which the Mural is to be located shall independently execute a

- separate agreement which shall provide that the Artist shall waive its rights to the Mural after two (2) years. ABG shall maintain the Mural for a period of two (2) years, and the Artist acknowledges that the license granted to ABG pursuant to this Paragraph expressly permits ABG to maintain the Mural.
- 2.6.2 <u>Copyright</u>. The Artist shall retain copyright of the Mural. The Artist grants permission to ABG to use the mural image in products in order to fundraise for ABG's mission. The Artist understands that this includes reproduction, adaptation, publication, and display. The Artist represents and warrants that it shall not make any claim to the copyright of the Artwork and/or Mural against ABG or against any ABG employee, representative, officer, official, agent, or volunteer.
- 2.7 <u>Media</u>. The Artist may publish on social media regarding their participation in the Program provided that the Artist mentions that such participation is conducted in cooperation with ABG and the Program.
- 2.8 Independent Contractor. The Artist is and will remain throughout the Term, an independent contractor. The Artist is not and will not become an employee, partner, or principal of ABG, and the Artist agrees that they are not entitled to the rights or benefits afforded to ABG's employees, including disability or unemployment insurance, workers' compensation, medical insurance, sick leave, or any other employment benefits. The Artist does not, and will not, stand in a fiduciary capacity with ABG. The persons performing the Services under this Agreement on behalf of the Artist shall at all times be under the Artist's exclusive direction and control. The Artist shall not incur or have the power to incur any debt, obligation, or liability whatever against ABG, or bind ABG in any manner. Subject to the terms and conditions of this Agreement, the Artist may represent, perform services for, and contract with additional clients, persons, or companies as the Artist, in their sole discretion, deems prudent.
- Use of Employees, Agents, Volunteers, or Subcontractors, Assignment. The Artist may use or employ subcontractors or others working on the Artist's behalf to perform the Services, upon twenty-four (24) hours' written notice to the Program Manager. The Artist shall remain solely responsible for compliance with this Agreement and must ensure that all persons working on behalf of the Artist comply with all the terms hereunder in connection with the Services. This Agreement may not be assigned without written agreement by both Parties.

#### 3. COMPENSATION

3.1 Contract Sum. ABG's compensation rates are set to compensate artists in a manner aligned with ABG's view of the importance of the arts to community, unity, and growth. The total compensation for the Services is, and shall not exceed [\$3500] ("Contract Sum"). Unless otherwise set forth herein, ABG shall not be required to pay to the Artist any additional sum to the Contract Sum. ABG shall supply all required materials such as but not limited to, paint and scaffolds, agreed upon in writing by the Program Manager after discussing what is needed with the Artist. In no event shall ABG be required to reimburse the Artist.

- for materials or supplies purchased by the Artist, unless such reimbursement is authorized in advance and in writing by the Program Manager.
- 3.2 <u>Payment</u>. The Artist shall notify the Program Manager in writing when the Mural design is finalized after any agreed upon revisions. ABG will pay a deposit to the Artist of fifty percent (50%) of the Contract Sum after the design is approved and finalized. The Artist shall contact the Program Manager when the Mural installation is complete. Upon ABG's confirmation that the Artist has completed the Services to ABG's reasonable satisfaction, ABG shall pay the Contract Sum to the Artist within seven (7) days.

#### 4. MISCELLANEOUS

- 4.1 <u>Survival</u>. All obligations arising prior to the expiration or termination of this Agreement and all provisions of this Agreement allocating liability between the Artist and ABG shall survive the expiration or termination of this Agreement.
- 4.2 <u>Applicable Law; Venue</u>. The internal laws of the State of California shall govern the interpretation and enforcement of this Agreement. In the event that either Party brings any action against the other under this Agreement, the Parties agree that trial of such action shall be vested exclusively in Los Angeles County.
- 4.3 <u>Severability</u>. If any provision of this Agreement is held invalid, the remainder of this Agreement shall not be affected thereby, and all other parts of this Agreement shall nevertheless be in full force and effect.
- 4.4 No Implied Waiver of Breach. The waiver of any breach of a specific provision of this Agreement does not constitute a waiver of any other breach of that term or any other term of this Agreement.
- 4.5 <u>Counterparts</u>. This Agreement may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
- 4.6 No Third-Party Beneficiaries. There are no intended third-party beneficiaries under this Agreement and no such third parties shall have any rights or obligations hereunder.
- 4.7 <u>Limitation of Liability</u>. To the fullest extent permitted by law, ABG shall have no liability with respect to ABG's obligations under this Agreement or otherwise for consequential, exemplary, special, incidental, or punitive damages even if ABG has been advised of the possibility of such damages.
- 4.8 <u>Amendment, Termination</u>. This Agreement shall not be amended or terminated without prior written consent of both the Artist and ABG. The Program Manager is duly authorized to amend the Agreement on behalf of ABG.
- 4.9 <u>Attorneys' Fees</u>. If any legal action, including arbitration or an action for declaratory relief, is brought to enforce or interpret the provisions of this Agreement, the prevailing Party shall be entitled to recover reasonable attorneys' fees from the other Party. These fees, which may be set by the court in the same action or in a separate action brought for that

purpose, are in addition to any other relief to which the prevailing Party may be entitled. This provision applies to the entire contract; and each Party to this contract was represented by an attorney in the negotiation and execution of the Agreement.

IN WITNESS WHEREOF, ABG and the Artist have caused this Agreement to be fully executed and delivered as of the Effective Date.

## Mural makes progress at Dayton **Heights Elementary**

Los Angeles City Councilman Mitch O'Farrell, 13th District, joined students on July 31 to paint a new mural at Dayton Heights Elementary School, located at 607 N. Westmoreland Ave.

The group also included community members, representatives of the local nonprofit Arts Bridging the Gap, and artists Ethel and Carlo Zanfranco. Titled "Hybrid," the mural covers the entire south-facing exterior of the school and was designed by the 2019-20 5th grade students at Dayton Heights Elementary School and Arts Bridging the Gap. The Zanfrancos created the final design and led the painting project.

The vision for the mural came from O'Farrell's office, which wanted to bring a positive and meaningful project to the school. The campus is located in a community historically overlooked for artistic experiences and beautification efforts, he said.

O'Farrell participated in online design sessions hosted by Arts Bridging the Gap and shared stories about his artistic background with the students and parents, encouraging them to explore their creative interests. The sessions helped the students and parents connect with each other and express their feelings about the challenges of the pandemic. The students shared ideas and themes and drafted designs that were incorporated into the final mural.

The mural also features an important message for the students and the community. "Once upon a very difficult time, students had to adapt to a different way of living and learning. A change was needed, and our old ways were unfurling," the mural reads. "Though we pushed through in environments that were isolated, we pushed together in a spirit united."

The mural is expected to be unveiled on Aug. 16 at the conclusion of the first day of the new school year. For information, visit cd13.lacity.org.

#### **Written Narrative**

Arts Bridging the Gap is committed to creating murals across Los Angeles that bring the community together and that uplifts the voice of our city's youth. One of these murals is this proposed mural in South Park. Arts Bridging the Gap is grateful for the support of numerous grant making foundations, including city, county, and state grants that are part of making this project possible along with individual contributions.

Arts Bridging the Gap works with a diverse range of artists and educators. ABG makes sure to choose the most appropriate artist(s) based on a variety of factors for each project. For this South Park mural project, ABG selected Amani Holbert and Ethel Zarinana from a list of ABG's professional artists. ABG chose these two artists, whom they have been working with for 1-3 years, because of their passion for art as change makers, their responsible/responsive nature, their empathetic and passionate ability working with youth, and their skillset as muralists. They were selected to work together to represent the direct parallel of the history and future of this project. South Park used to be run by two gangs who often clashed with one another – one Latino gang and one Black gang. They created a truce 30 years ago and are now working to change the nature of gangs and help build a brighter future for the youth of the neighborhood. For this reason, Ethel who identifies as Latino and Amani who identifies as Black, were selected to work together to help represent both voices in a shared future.

A primary goal of this project is to paint a public mural through a process that is meaningful for the community, providing an uplifting outlook for the future. The design was created as a collaboration between the two selected muralists and the youth at South Park's summer camp. Arts Bridging the Gap and the muralists conducted art workshops including games, discussions, and art-making. This allowed for free expression and thought-provoking understandings, so that the muralists could see through the communities' eyes and gain a deeper perspective on how to make a public art piece meaningful for everyone in the neighborhood. In addition to working with the youth, Arts Bridging the Gap also spoke to adult community members to understand the community's history and how best to represent their community. Based on the public meeting held, community members are excited to see this mural enrich the vibrancy of their everyday.


The design fits within the existing environment by filling up the entire side wall of the Teen Building, incorporating the park colors of nature, bringing life to the gray surrounding walls, and providing a positive, uplifting message for all who walk by, drive by, and play baseball across from the wall. This is especially beneficial for the adolescents who use this space, entering through the doors painted with the design that signifies hope and potential for the future. This design is also right next to the CSP office, another mechanism of bridging the gap, as police officers will also be involved in helping paint this mural with the community.

The wall will be primed by Arts Bridging the Gap and the muralists to prepare it for painting with the community. The wall is in great condition, so it does not need much preparation besides priming it. The muralists will arrive the night before the community painting day to outline the wall with their design, so it is straightforward for the community to enjoy painting. The following day is the community paint day, in which all community members are invited, especially the youth who helped design it. They start the mural, because this is the easiest and most fun part – big color blocks to get going. It is a fun day of bringing everyone together, with music, food, and laughter. After this community day, the muralists spend a few more days adding details and perfecting the mural for a professional look.

Arts Bridging the Gap takes responsibility for the maintenance of the mural. Georgia Van Cuylenburg, the Founding Director (1433 N Hayworth Avenue, Unit 5, West Hollywood, CA 90046, georgia@artsbridgingthegap.org, 323-244-0720) will arrange to have the mural cleaned and/or repaired. Arts Bridging the Gap agrees to maintain the mural for five years with funds specifically saved for this purpose, but Arts Bridging the Gap often ends up helping repair damages throughout the mural's lifespan. Attached is a letter in which Georgia Van Cuylenburg accepts this responsibility in committing to the maintenance. Also attached is a letter agreement from Woods Maintenance Services agreeing to coat the mural and maintain it if ever it gets damaged.





The Neon Dog is a reconditioned, electrically rotating neon sign in the shape of a dog (10'6" high, 10'9" at its widest), and part of the City of West Hollywood's Urban Art collection. The proposed project includes the installation of the Neon Dog atop a 12'-tall vertical support pole (with corresponding structural foundation and electrical connections) at the Park's Sunset Boulevard entrance located between North Kings Road and North Sweetzer Avenue.

The mural is painted on the exterior south wall of the ONEgeneration Senior Enrichment Center and measures 160' in length and 15' in height.

The mural received Conceptual and Final Approval from the Cultural Affairs Commission (CAC) on May 11, 2022. The CAC staff report stated that "The Department of Cultural Affairs in partnership with the Council Office and Office of Community Beautification will be the primary stewards of the mural's maintenance," however, that statement was incorrect.

This report aims to correct that error and memorialize the agreement in place, pursuant to subsequent conversations between the applicant, Department of Cultural Affairs (DCA), and the Department of Recreation and Parks (RAP), that ONEGeneration will be responsible for the maintenance of the mural.

To whom it may concern,

As Founding Director of Arts Bridging the Gap, I am formally expressing our commitment to take ownership of maintenance of all walls and art pieces included in the Los Angeles Street Art Initiative.

We are working directly with the Department of Beatification Services to ensure all maintenance performed meets City standards and requirements.

Within this commitment we are responsible for:

- Coordinating and overseeing any graffiti removal
- Repairing and restoring any art work within the mural that has become unsightly.

We commit to scheduling any needed repairs within 14 days of notice given by the property owner. All repairs will be completed within 1 month of notice given by the property owner. If repairs are not completed within this one month time period we grant the property owner permission to remove and/or paint over the mural.

We have an agreement with Graffiti Control Systems – an official contractor with the City of Los Angeles to perform all graffiti coatings (no sacrificial) and to perform all power washing as needed to remove graffiti.

We will continue this commitment for the life time of the mural (minimum five years for city properties and minimum two years for private buildings.)

#### Financial commitment:

All walls that are 350sqft and under are covered by the city Mural Ordinance. We commit to funding all maintenance on walls that exceed this size and have made previsions within our organizational budget to do so.
