CALL TO ORDER

APPROVAL OF THE MINUTES

GENERAL MANAGER'S UPDATE

Matthew Rudnick, Executive Officer, gave an Emergency Management update on the department, and shared that the Emergency Management Department has activated the adverse weather plan and that RAP is working closely with EMD to provide the necessary resources and support needed to address any issues.

Mr. Rudnick shared highlights from our Recreation and Aquatics divisions. He stated the winter camps are concluding their third week of camp. Mr. Rudnick mentioned that our Winter Leagues and camps will begin on January 9, 2023. On Saturday, January 14th at Griffith Park the urban oncologist will resume the nature walks. VERBAL REPORT AND FINDINGS TO CONTINUE TELECONFERENCING PURSUANT TO GOVERNMENT CODE SECTION 54953 (AB 361)

President Sylvia Patsaouras reported that the board must consider a determination, in accordance with AB 361 Section 3(e)(3) that, while the state of emergency due to the Covid-19 pandemic, as originally proclaimed by the Governor on March 4, 2020, remains active and/or state or local officials have imposed or recommended measures to promote social distancing, this legislative body has reconsidered the circumstances of the state of emergency and that the state of emergency continues to directly impact the ability of the members of this Board, and the ability of the members of all of this Board's advisory bodies, including, but not limited to, all park advisory boards, the Greek Theatre Advisory Committee, and the Golf Advisory Committee, as well as the public who might attend these meetings, to meet safely in person and/or state or local officials continue to impose or recommend measures to promote social distancing.

President Sylvia Patsaouras made motion for approval of such findings and Commissioner Bayne seconded the motion. Public comment relevant to this item were invited, with no requests submitted. There being no objection to the motion, the motion was unanimously approved by a vote of 4-0.

COMMISSION TASK FORCE UPDATES

Commission Task Force on Concessions

Commissioner Chase reported that this Task Force met and discussed in great detail the Griffith Park Pony Rides and how the Department plans to reimagine this space. Commissioner Chase stated that General Manager Jimmy Kim provided the constituents with information as to why the department made their decision to cancel the contract.

Commission Task Force on Facility Repair and Maintenance

Commissioner Halper reported on two items discussed at the Facility Repair and Maintenance Task Force. The first is a Hansen Dam Recreation Area - Holiday Lake Feasibility Study for the development of an aquatic based recreation area in the Santa Monica Mountains that would be expected to be operated by RAP, and he suggested that the presentation be made available to the Board. The second is the Venice Beach - Lifeguard Tower, which has received substantial support in a community petition for the restoration and preservation of the tower, and he recommended that the item be placed on the agenda of an August 2023 meeting of the Task Force to allow an opportunity for the advocates for the preservation of the tower to present their plan and commitment for restoration and use of the tower.

COMMISSION BUSINESS

Comments from the Commissioners on Matters within the Board's jurisdiction and Requests by Commissioners to Schedule Specific Future Agenda Items were requested. Commissioner Halper Requested a report back regarding recommendation of selection and development of sites to be used for pickle ball play. He would also like a report back on a noise level assessment associated with pickle ball Commissioner Chase requested a future update on the Venice beach lifeguard tower. Commissioner Chase would also like an update on Dearborn Park, as well as the Los Angeles and Hansen Dam Equestrian centers. Commissioner Halper requested a status update on the restriping of court 7 at Pacific Palisades tennis court for pickle ball.

There being no further business to come before the Board, the Meeting adjourned at 11:20 a.m.
