I believe the said minor to be in proper physical condition to partake in such sports activities. I agree to relieve the **City of Los Angeles Department of Recreation and Parks**, its officers, agents, and employees from any liability in connection with any injury to my child in connection with the league. I, the undersigned parent of _____, a minor, do hereby authorize **Montecito Heights Recreation Center** staff, as agents for the undersigned, to consent to x-ray examination, anesthesia, medical or surgical diagnoses, or treatment under the provisions of the Medical Practices Act on the staff license hospital, whether such diagnoses or treatment is rendered at the office of said physician or at said hospital. It is understood that this authorization is given in advance of any such diagnosis, treatment or hospital care which the aforementioned physician in the exercise of good judgment may deem advisable. This authorization shall remain effective for the duration of the program unless revoked in writing and delivered to said agent. I understand that the recreation facility CARRIES NO INSURANCE.
