- All Rosters, Waivers, Code of Conduct, and Add/Drop Forms may only be submitted to the Valley Sports Office. Scorekeepers/Referees have been instructed NOT to accept any paperwork from teams and/or managers.
 - Legal uniforms are required by the 2nd week of games to avoid penalties. Uniforms must have permanent numbers on the front and back and meet Muni rule specifications (see Rules for Governing Play)
 - Team Roster is due in the Sports Office by the 3rd week of games. Only Original Complete Rosters Accepted. Receipt date affects Win Points, Protests, & City-Wide Tournament invitation.
 - The last day to submit an Add/Drop Form is prior to the 6th week of games.
- NOTE: Players MUST participate in a minimum of 5 league games to be eligible for playoffs and/or City-Wide Tournaments
