2024 METRO REGION BASKETBALL TOURNAMENT

TOURNAMENT FORMAT

1. All Citywide Basketball rules shall apply.
2. All participants must sign in prior to playing in the game.
3. The visiting team will be listed on the left. They will choose their bench and must shoot at the basket opposite from their bench in the first half.
4. Home team will wear the lighter color jersey if listed **on top** of the Regional bracket.
5. Coaches must sign a Code of Conduct and will be responsible for the conduct of their players and fans. Also, ALL coaches must have taken the PCA coaching workshop in order to coach in the tournament. **Coaches are reminded that Sportsmanship is the top priority in the tournament.**
6. Teams forfeiting due to A. Code of Conduct violation B. Playing an ineligible player during the tournament will forfeit their last game, if this occurs during the single elimination portion of the tournament, their opponent shall advance.
7. **RULES PROTEST PROCEDURES: Protests will only be accepted concerning a misinterpretation of the rules.** If there is a protest, ONLY the Head Coach and/or Assistant Coach must notify officials prior to the second dead ball. The game will be stopped at that point and the committee will be called to make the final decision. The committee's decision shall be final. Protest time is not part of game time. Protests will not be heard on official's judgment calls. If a team loses their protest they also lose a timeout.
8. **ELIGIBILITY PROTEST PROCEDURE:** The Sports Board has taken reasonable steps to verify that all players in the tournament meet eligibility requirements. All players must appear on a league roster and have shown a valid proof of age. Any eligibility protests require proof from the coach that is protesting. A hearing will be held on such protests and the decision of the committee is final. Eligibility protests must be made immediately following the game.
9. **Games will start on time.** There is no grace period. It is up to each team to allow proper travel time to get to each game venue on time.
10. Teams should arrive at least **30 minutes prior to game** time in order to sign in.
11. In all Brackets, teams have been divided into pools, varying according to the number of teams entered by district.
12. **The top 2 teams will advance in each qualifying pool.** The Qualifying Teams will move on to the Regional Tournament Single Elimination Round.
13. Pools are selected by random draw.
14. In the event of a tie in a pool, the tie breaker will be as follows:
 - Head to Head match-up between tied teams
 - Fewest points allowed in games played by tied teams
 - Fewest points allowed in all games played

Citywide Youth Sports Committee **SPORTSMANSHIP STATEMENT**

Good sportsmanship among spectators, parents, coaches, players, and officials is expected.

We require that ALL spectators practice supportive and encouraging behavior at all times.

Inappropriate conduct and/or negative gestures are not allowed during any part of the game.

Examples of such behavior include the following:

- **Taunting the opposing team and their supporters.**
- **Derogatory comments to the officials/referees and others**
- **Distracting players with stomping, yelling, and/or banging devices.**
- **Usage of loud sounds such as horns/whistles/bells are prohibited.**

Failure to comply with the above rules may officially end the game and result in a forfeit loss for the offending team(s).

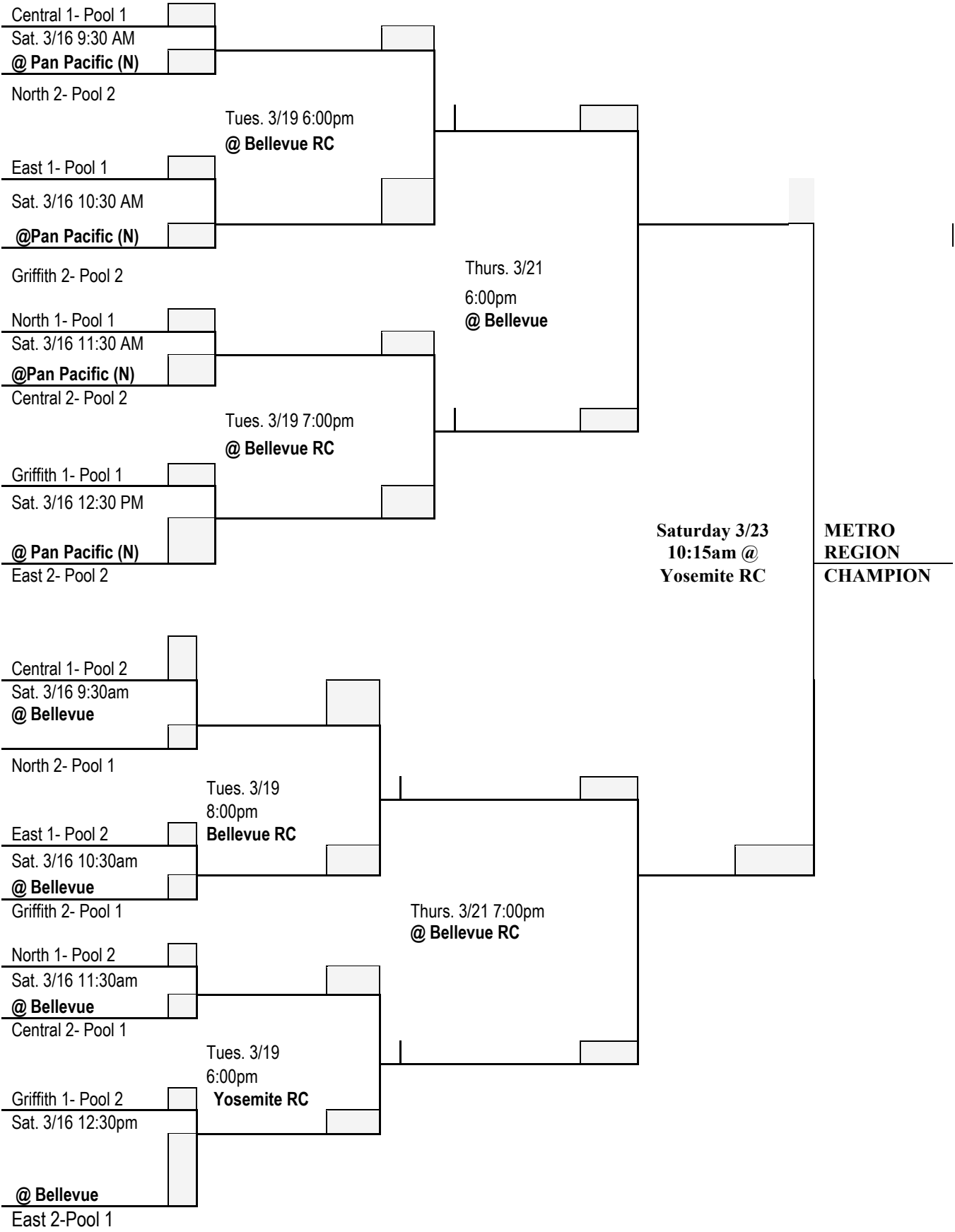

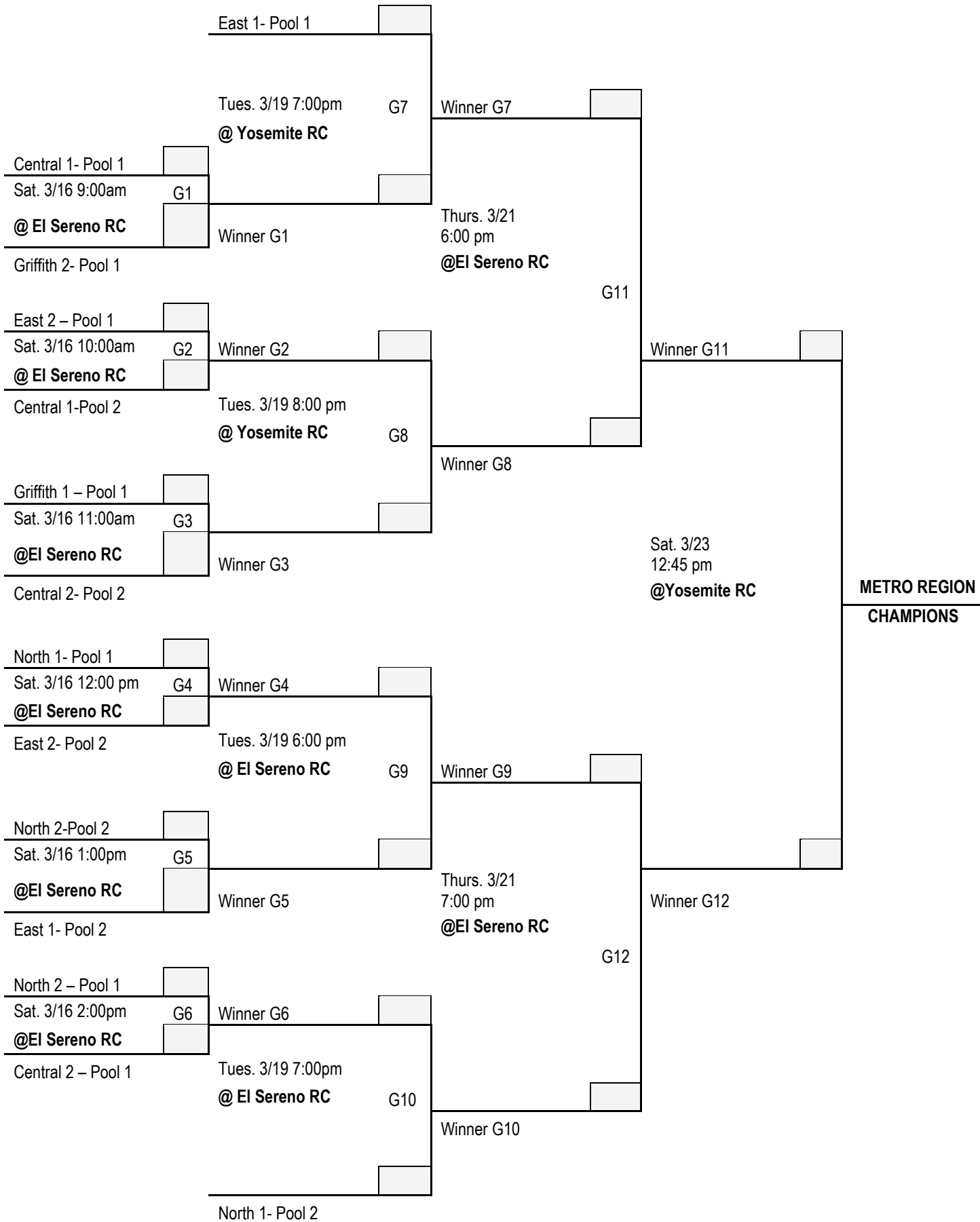

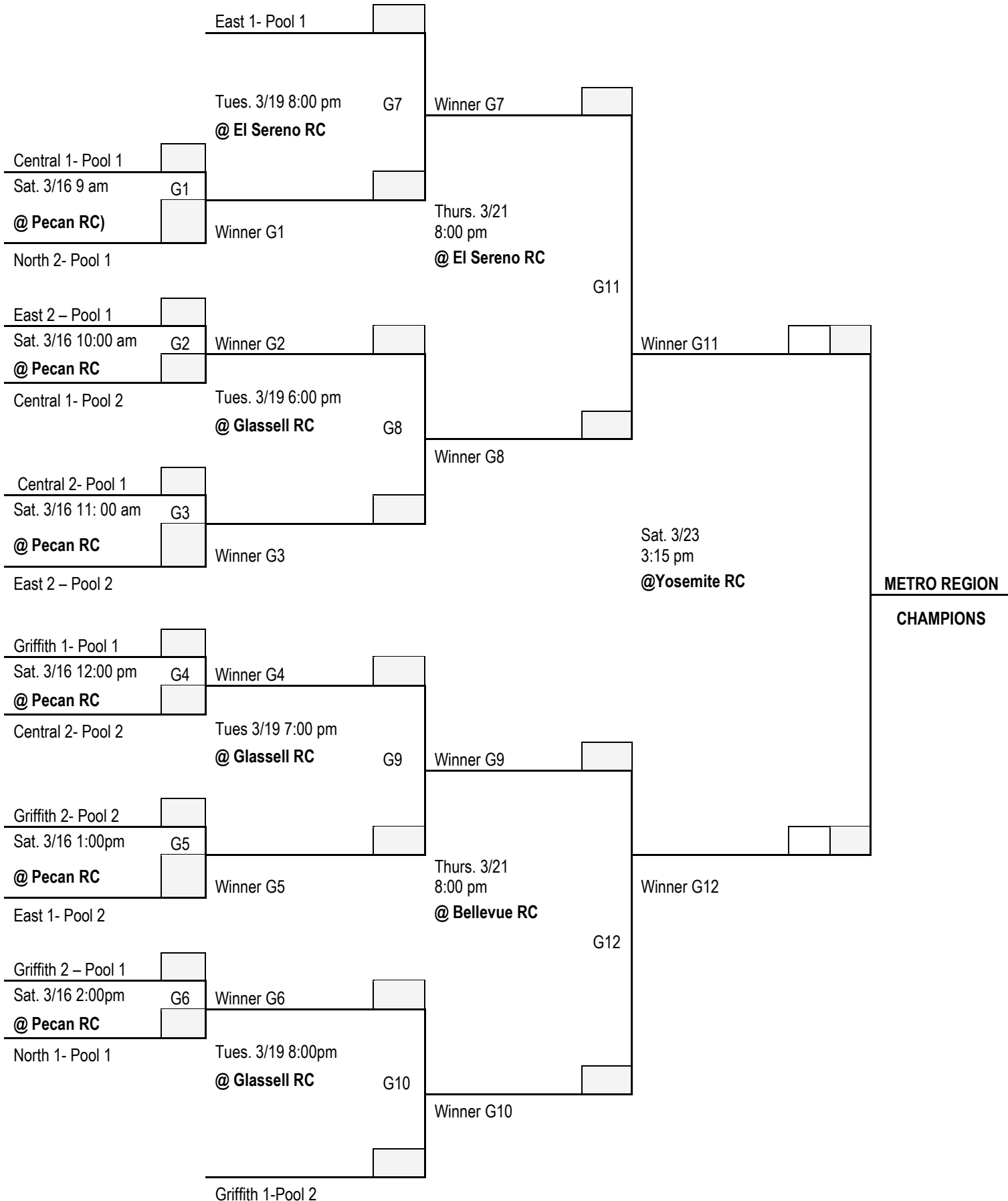
